Note:

1. #The vacant post of Medical Officer is being recruited for the Dispensary-cum-Branch Office (DCBO), Sadashivpet. The posting will be at DCBO-Sadashivpet, which falls under the jurisdiction of the ESIC Regional Office, Hyderabad, Telangana.

2. These vacancies are provisional and may increase or decrease subject to the actual requirement for patient care and NMC requirement. The Competent Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice in the interest of patient care.

3. The dates of walk-in Interview as mentioned against the department are final and no change will be made. The candidates have to make necessary arrangements by their own for attending the Walk- in Interview.

4. Reservations will be as per Govt. of India guidelines issued from time to time.

5. In case of non-availability of reserved category candidates in the post of Professor/Associate Professor/Assistant Professor, the vacancy may be filled up, for less than 45 days, under UR category for fulfilling the urgent requirement.

I. Candidates with experience as Associate Professors/Assistant Professor may also apply for the post of Professor/Associate Professor. Such candidates will be considered only if no eligible candidates with Professor/Associate Professor-level experience attended or applied. However, if selected, they will be appointed at the pay scale of an Associate Professor/Assistant Professor on the recommendation of the selection board.

II. In case of non-availability of Super-specialty Faculty (MCh/DM/DrNB) for Super-specialty Departments, the Faculty from the concerned parent Broad Specialties will be considered as per NMC Gazette Notification dtd.30-06-2025.

6. The eligibility criteria including the age, educational qualification and period of experience, as prescribed in the advertisement will be determined with reference to the date of Walk- in Interview.

7. Candidates intending to apply for multiple cadres in same department shall submit separate applications.

8. As per NMC TEQ dated 14.02.2022 regarding “**Determination of equivalence of the qualification of DNB (Broad Specialties) with MD/MS and DNB (Super Specialties) with DM/M.Ch**” -The Diplomat of National Board (DNB) in broad specialty and super specialty qualifications when granted in a medical institution with attached hospital or in a hospital with the strength of five hundred or more beds, by the National Board of Examinations, shall be equivalent in all respects to the corresponding broad specialty (MD/MS) and super specialty (DM/M.Ch) postgraduate qualification, but in all other cases, senior residency in a medical college for an additional period of one year shall be required for such qualification to be equivalent for the purposes of teaching.

9. The experience should be recognized by the Medical Council of India or the statutory body concerned with the system of medicine as valid teaching experience for teaching posts and certificate thereof or any other valid proof in support thereof should be submitted and a certificate to this effect is to be submitted.

Note: The crucial date of determining the age limit, work experience and other criteria regarding eligibility for the post shall be the date of Walk- in Interview.

The candidates seeking reservation under EWS category should produce an Income and Asset Certificate for Financial Year (FY) 2025-26 and issued on/after 01.04.2025 as per Annexure-I of Govt. of India, Min of Personnel, Public Grievances & Pensions, DOPT Office Memorandum No 36039/1/2019-Estt (Res) dated 31.01.2019. Pro-forma enclosed as Annexure-I.

The candidates seeking reservation under OBC category should submit OBC (Non-Creamy Layer) Certificate based on the income of the Financial Year (FY) 2022- 2023, 2023-2024 and 2024-2025 and issued on/after 01.04.2025 and shall be issued by an officer not below the rank of Sub-divisional officer or equivalent authority of the concerned state for central Govt. Jobs. (Pro-forma enclosed as Annexure-II).

The candidates seeking reservation under SC/ ST category should submit SC/ST certificate issued in the prescribed pro-forma and shall be issued by an officer not below the rank of Sub-divisional officer or equivalent authority of the concerned state for central Govt. Jobs (Pro-forma enclosed as Annexure-III).

b) i) **Educational Qualifications and Experience:**

A recognised MBBS degree qualification included in the First Schedule or Second Schedule or Part II of the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956(102 of 1956), as amended from time to time. Holders of educational qualifications included in Part II of the Third Schedule should also fulfill the conditions specified in subsection (3) of section 13 of the Indian Medical Council Act, 1956 (102 of 1956). ii). Compulsory rotating internship.

ii) In case of non-availability of Super-specialty Senior Residents (MCh/DM/DrNB) for Super-specialty Departments, the Senior Residents from the concerned parent Broad Specialties will be considered.

iii) In dentistry department, candidates with MDS in (1) Prosthodontics, Crown & Bridge, and (2) Conservative Dentistry & Endodontics will be preferred.

iv) For the post of Medical Officer at DCBO-Sadashivpet, preference will be given to candidates who have completed post-graduation in General Medicine (MD/DNB).

c) **Pay and Allowances:**

These remunerations are subject to revision whenever there is a change in the Dearness Allowance (DA) rates, as per the directives from the ESIC Headquarters Office, in accordance with the policies for Central Government Employees.

iv) **No Private Practice is allowed during the tenure of service in ESIC.**

d) Term of Contract:

i) The initial period of contract for faculty will be for 01 year, extendable every year up to a maximum of 03 years or 70 years of age, whichever is earlier, subject to satisfactory performance. Barring unsatisfactory performance, the incumbents of faculty would serve the initial first year of contract, independent of regular faculty joining during this period. However, the contract would be terminable on one month notice, on joining of regular faculty in the 2nd/3rd year of contract.

ii) The tenure in respect of Senior Residents on contract basis; the engagement will be initially for 01 (One) year extendable every year up to three years on satisfactory performance and conduct.

iii) The tenure in respect of Medical Officer on contract basis; the engagement will be 01 (One) year only.

iii) The Contractual engagement may be terminated / discontinued on either side giving one month prior notice or one month's gross salary in lieu to this effect without assigning reason.

iv) Senior Resident is a tenure post. Individuals with previous experience in Senior Residency at Central or State Government institutions may have their tenure reduced based on the duration of previous service.

v) Other terms and conditions will be applicable as issued by competent authority from time to time.

e) The following documents should be submitted at the time of Walk-in Interview:

i) Two copies of recent self attested passport size photograph.

ii) Self-attested copies of certificates and testimonials in support of proof of age (Date of Birth), Educational Qualification, Experience and Research papers, Publications etc.

iii) Original certificates and testimonials in support of proof of age (Date of Birth), Educational Qualifications, Experience and Research Papers, Publications, PG Course recognition Certificate etc., Should be submitted at the time of walk-in Interview.

f) Terms & Conditions:

1. In case, the selected candidate resigns, he/she has to serve one month notice period or have to pay one month salary.
2. Candidates selected to the post of Professor/Associate Professor/Assistant Professor and Senior Resident have to deposit an amount Rs.100000/- as security deposit at the time of joining. The security deposit will be forfeited in case;
 - a) The selected candidate resigns/leaves within 01 year.
 - b) The selected candidate resigns/leaves after 01 year (as the case may be) of joining but fails to fulfill the Notice period conditions.
3. As the contract being for one year, absence for the period of 15 days or beyond without prior permission/approval of Competent Authority will be treated as abandonment of duty and the contract will be terminated without any notice and security deposit will be forfeited.
4. The absence from work for a period of fifteen days without proper permission of the Competent Authority will amount to voluntary abandonment of engagement and automatic termination. The Medical Officers are required to mark attendance manually as well as on NMC Face Aadhar Enabled Bio-metric Attendance System (Face AEBAS) daily during scheduled working days.

g) **How to Apply:**

ii) All the candidates should produce original documents in respect of all the parameters at the time of Reporting for Walk-in Interview.

h) **Application Fee:** The application fee will be collected through online payment system (SB Collect) at the venue at the time of registration / document verification.

i) **Selection Procedure:**

i) The selection will be made on the basis of performance of the candidate in the interview before the Selection Board. Selection procedure may be altered at the discretion of authority, when more number of candidates appeared for interview.

ii) Result will be displayed on ESIC website.

iii) Selected candidates will have to join immediately after receipt of the offer of appointment.

iv) Upon selection, if the candidate fails to report on or before the stipulated last date of joining, his/her appointment stands cancelled and the next eligible candidate will be automatically be deemed selected.

j) **General Instructions:**

i) Mere submission of application does not confer any right to the candidate to be eligible for interview or selection.

ii) Application should be submitted in the prescribed format only. The applications submitted in any other format OR incomplete applications will be summarily rejected. **The candidates may obtain the application from the website and submit the same duly filled in all aspects during the certificate verification on the date of Walk-in Interview.**

iii) The candidates may ascertain their eligibility and report for interview on the scheduled date and time for Walk-in Interview. Candidates reporting after scheduled time will not be allowed to attend the interview process.

iv) ESIC reserves the right to cancel the recruitment process at any stage at its discretion and such decision will be binding on all concerned.

v) Wrong declarations/submission of false information or any other action contrary to law shall lead to cancellation of the candidature at any stage in addition to suitable legal action.
