## **General instructions for the Non-teaching/Administative Positions**

**Employment Notice No.GAD/NT/GIA/EmpNotice/31258/2025, Date: 10/12/2025**

1. The candidate who desires to apply for more than one Non-Teaching/Administrative post will be required to apply separate application and an additional application fee along with each application.
2. The appointment of the selected candidate for the said post on regular basis from the grants released by state government shall be subject to the conditions laid down by the state government / university from time to time. Recruitment of Non-teaching/Administrative post as mentioned shall be as per Resolution No. KhRCh/2002/57/(Part-4)/z.1, Dated 18-10-2023 of Finance Department, Government of Gujarat on fix pay for the first five years.
3. Applicants must submit the application through online recruitment portal at <https://vnsgunt.samarth.edu.in> on or before dt.10/01/2026 till 6:00 pm and must upload the necessary documents with the online application.
4. The applicant must ensure that he/she fulfills the eligibility conditions for the Post applied as per respective Notifications.
5. In no circumstances any content of the application form should be modified.
6. Reservation for SC/ST/SEBC/EWS and Persons with Benchmark Disabilities will be as per the existing policy of Government of Gujarat.
7. Candidates belonging to reserved category (SC/ST/SEBC/EWS) or physically handicapped or Ex-serviceman must attach necessary certificate from the competent authority of the state. SEBC candidate should furnish the Current Financial Year's "Non-Creamy Layer Certificate" in the prescribed Performa along with his/her application form, failing which the candidate will not be entitled to get the benefit of reserved category. SC, ST, SEBC and EWS candidates of origin of Gujarat can only avail the benefit of reservation.
8. Candidates seeking reservation under Scheduled Caste (SC)/ Scheduled Tribe (ST) Category are required to submit Certificate in the format prescribed by the Government of Gujarat.
9. Candidates applying for the Post (s) reserved for socially and Economically Backward Class (SEBC) should submit a Self-Attested Copy of a Valid Caste Certificate specifically mentioning Creamy Layer-Exclusion in the format prescribed by the Government of Gujarat.
10. Candidates applying for the Post (s) reserved for EWS Category have to submit Certificates for eligibility for reservation in favour of EWS in the format as prescribed by the Government of Gujarat.
11. Applicants are advised to apply to the University well in advance without waiting for the last date and time to avoid any kind of delays due to unforeseen events or circumstances. The University shall not be responsible for any delay at any stage.

12. Applicants who are already in service should apply through their present employer. Direct application shall not be considered. However, due to any unavoidable circumstances, if the application through proper channel is likely to be delayed then an advance copy along with required application fee may be sent on or before the due date mentioning ADVANCE COPY on envelop. Persons employed after making application in response to this advertisement should bring "NO OBJECTION CERTIFICATE" at the time of interview from their employers.
13. The application fee will not be refunded once the form has been submitted by the applicant.
