Online applications are invited from Scouts & Guides persons having minimum educational and Scouts & Guides Qualification as given in Para 2 & 3 below, for recruitment in Grade Pay Rs. 1900/- and 1800/- (Revised Pay Scale after 7th CPC Pay Matrix Level – 02 & 01) against Scouts & Guides Quota 2025-26 on North Central Railway till 23.59 Hrs of closing date for the quota as indicated below:

- ➤ The candidate may apply for Pay Matrix Level 2 (Grade Pay Rs. 1900/-) or Pay Matrix Level 1 (Grade Pay Rs. 1800/-) or both.
- The above quota is open to all eligible candidates provided that he/she is fulfilling the prescribed norms.

**Note:** Candidates willing to apply for both the categories should fill/tick both the categories while applying. Examination fee, as applicable, has to be paid separately for both the category.

#### 2. <u>Educational Qualification</u>:

- (a) For Pay Matrix Level-2 (Grade Pay Rs. 1900/-): The candidate should have minimum qualification of Intermediate or equivalent examination passed with 50% aggregate from any recognized Board/University. The condition of 50% marks is not to be insisted upon in case of SC/ST/Ex. Servicemen and the candidates possessing higher qualification i.e. Graduation/Post Graduation etc. from a recognized University. (Authority: RBE No.145/2014 dated 17.12.2014 & RBE No.82/1995 dated 01.08.1995)
  - ➤ **For Technical Posts** -Matriculation / SSLC plus ITI from recognized institutions of NCVT/SCVT (OR) Matriculation / SSLC plus Course Completed Act Apprenticeship.
- (b) **For Pay Matrix Level-1 (Grade Pay Rs. 1800/-):** The candidate should have minimum qualification of 10<sup>th</sup> pass from any recognized Board or ITI or equivalent or National Apprenticeship Certificate (NAC) granted by NCVT.
- **3. Minimum Scouts & Guides Qualification:** The candidate should possess the following certificates in support of his/her Scouts & Guides qualification:-
  - (a) A President's Scout/Guide/Ranger/Rover **OR** Himalayan Wood Badge (HWB) Holder in any section;
  - (b) Should have been an active member of a Scouts organization for at least 5 years. The 'Certificate of Activeness' should be as per **Annexure 'G'** and
  - (c) Should have attended two event at National level **OR** All India Railways' level **AND** Two events at State level.

#### 4. <u>Age</u>:

- (a) Candidates applying for Grade Pay Rs. 1900 (Pay Matrix Level 02) i.e. Catg. No. 1 should be aged between 18 to 30 as on 01.01.2026. (i.e. he/she must have been born not earlier than 01.01.1996 and not later than 01.01.2008)
- (b) Candidates applying for Grade Pay Rs. 1800 (Pay Matrix Level 01) i.e. Catg. No. 2 should be aged between 18 to 33 as on 01.01.2026. (i.e. he/she must have been born not earlier than 01.01.1993 and not later than 01.01.2008)
- **Note :-** 1. The date of birth of candidates should be between the dates given 4(a) & 4(b) above (both dates inclusive)
  - 2. The candidate should also note that, once a Date of Birth has been claimed by him and entered in the records of the Administration for the purpose of admission to the examination, no change will be allowed subsequently on any grounds whatsoever. Birth certificate should be issued by competent authority.
  - 3. 10th/Matriculations Certificate/Equivalent Educational Certificate/Educational Certificate/School Leaving Certificate indicating date of birth are mandatory for D.O.B (Date of Birth) otherwise application will be rejected.
  - \* The lower and upper age limit will be reckoned on 01/01/2026.
- **4.1** Relaxation of Age: The upper age limit as mentioned in Para 4 (a) & (b) is relaxable as under subject to submission of requisite certificate.

#### 5. Syllabus for selection under Scouts & Guides Quota:

"History of Scouting/Guiding; Law & Promise; Organization - District & State level; Training Centre -District & State Level; Knowledge of Book; Scouting for Boys/Guiding for Girls in India, Motto, Left hand Shake; Salute; Prayer; Flag Song; National Anthem; Know the National & Scouting flags; Social Services at Various Occasions; Hiking; Proficiency Badges(How these are earned), Stages in Scouting/Guiding; Thinking Day; Progressive Training of Scouts/Guides/Rovers/Rangers; Pioneering; Handicrafts: Indian Railway Jamborette; National Jamboree; Jamboree on the Air. Organization at National level; National Training Centre, WAGGGS / WOSM- Uprashtrapati Award Competition; Prime Minister Shield Competition; Community Development Programme; Aims and Methods of Scouting; How Scouting is useful in producing better citizen?

#### 6. Conditions for recruitment:

- 6.1 Before applying candidate should ensure that he/she fulfils the minimum eligibility norms.
- 6.2 Before posting against any working post the candidate will have to pass the requisite medical examinations prescribed for the post conducted by the Railway administration.
- 6.3 For posts where there is initial training prescribed, candidates has to qualify the training before posting.
- 6.4 Selected candidates, if posted as Clerk cum Typist have to acquire typing skill within a period of 2 years from the date of appointment at the speed of 30 words per minute in English or 25 words per minute in Hindi on Typewriter and if typewriting skills are tested on Personal Computers (PCs), then 40 words per minute in English or 35 words per minute in Hindi. If they do not acquire the requisite typing skill within two years from date of appointment, for which they may get maximum three chances only as per extant rules, no additional time will be given and services of such candidates will summarily terminated.
- 6.5 A caste certificate on the prescribed format for recruitment in Central Government services issued by the competent authority in the case of SC/ST/OBC should be uploaded for the purpose of taking relaxation as admissible.
- 6.6 Selected candidates will be utilized by the administration for arranging activities/events etc. whenever need arises and they will also continue to perform the duties of the posts on which they shall be posted.
- 6.7 The Selected Candidates can be posted anywhere & on any posts as per administrative requirements.

#### 7. <u>Serving candidates</u>:

Serving Railway staff and those working in Quasi-Administrative offices of the Railway organization such as Railway Canteens, Co-operative Societies and Institutes shall have to upload No Objection Certificate (NOC) issued by their employer.

#### 8. Examination Fee:

- 8.1. For all candidates except those mentioned in Para 8.2 below Rs. 500/- (Rupee Five Hundred Only) with a provision for refunding Rs. 400/- to those who actually appear in the written examination. (duly deducting bank charges as applicable)
- 8.2. For candidates belonging to SC/ST/Ex- Servicemen/Persons with Benchmark Disabilities (PwBD), Transgender/Women, Minorities and Economic Backward Classes Rs 250 (Rupee Two Hundred Fifty Only) with a provision for refunding the same (deducting bank charges as applicable) to those who actually appear in the written examination.
- 8.3. Economically Backward Classes candidates means those whose annual family income is less than Rs.50,000/- They have to upload EBC certificate on prescribed format as per **Annexure-D**.
- 8.4. The examination fee should be paid ONLINE using internet banking or debit/credit cards (bank charges apply for all which will be borne by the candidates). Applications not accompanied with examination fee, wherever required, will be summarily rejected.

#### 9. **HOW TO APPLY**:

- 9.1. Candidates are required to apply ONLINE mode for a particular Post/Category on the website of Railway Recruitment Cell, Prayagraj i.e <a href="www.rrcpryj.org">www.rrcpryj.org</a>. Before applying, candidates are advised to go through the instructions available on the website. The onus is on the candidate to prove that all the information provided/ submitted by him/her in the application is true.
- **NOTE-I**:- Candidates should ensure that their Name, Father's Name, Date of Birth should exactly match as recorded in Matriculation or equivalent certificate. Any deviation found during Document Verification will lead to cancellation of candidature and also to debarment. In case any candidate has formally changed the name, then gazette notification or any other legal document, as applicable should be submitted at the time of Document Verification. Such candidates should indicate their changed name. However other details should match with the matriculation certificate.

- **NOTE-II:-** Candidates are advised to indicate their active and personal mobile number and valid email ID in the ONLINE application and keep them active during the entire recruitment process as important messages will be sent by email and on mobile, which will be deemed to have been read by the candidates. The railway administration is not responsible for any delay in delivery of e-mail or SMS. Candidates should also check their spam-email folder.
- 9.2. The examination fee of Rs. 500 for each category (For candidates mentioned in Para 8.2 Rs. 250) should be paid ONLINE using internet banking or debit/credit cards (bank charges if any will be borne by the candidates). After making payment of fee relevant details are required to be filled in the prescribed column of the ONLINE application.
- 9.3. Candidates are required to upload their scanned colour photograph in Scout & Guide uniform of size 3.5cm x 3.5cm (Black & White photograph is prohibited) in JPEG format and 20 Kb to 30 Kb at appropriate place of website.
- 9.4. Candidates are required to upload their scanned Signature (in English or in Hindi) in JPEG format of size 10 Kb to 15 Kb on website.
- **NOTE**: Photographs: The colour photograph in Scout & Guide uniform of size 3.5 cm X 3.5 cm in JPEG format of 20 Kb to 30 Kb (not earlier than three months from the date of notification), with clear front view of the candidate without sunglasses, should be uploaded. Candidates may note that their candidature may be cancelled at any stage in case of uploading old/unclear photograph or Signature in Capital Letter or variations between photograph uploaded and the actual physical appearance of the candidate. Candidates are advised to keep two additional copies of the same photograph ready with them for bringing along with e-Admit Card and valid Photo ID at the time of examination.
- 9.5. During submission of ONLINE application, a Registration Number will be issued to each applicant. Candidates are advised to preserve/note their Registration Number for further stages of recruitment process / correspondence with RRC/NCR.
- 9.6. Only the certificate whose details are filled with relevant certificate in the "Online Application Form" will be scrutinize during DV/marks on certificate.
- **NOTE-I**:- Applications which are illegible, Mandatory columns not filled, incomplete, unsigned, signed in capital letters, without photo of candidate, not having requisite fee (if applicable) are liable to be rejected.
- **NOTE-II**:- In case the application is rejected, candidates will be able to view their status ONLINE on the website of RRC/NCR concerned along with the reasons for rejection(s). SMS and e-mail alerts shall also be sent to the candidates on their registered mobile number and e-mail ID, as indicated in their ONLINE application. Candidates whose application/ candidature are rejected will NOT be intimated by post.
- **NOTE-III:** To avoid last minute rush, candidates are advised in their own interest to submit ONLINE application much before the closing date since there may be a possibility of inability/failure to log on to the website of RRC concerned on account of heavy load on the internet or website jam during last days.
- **NOTE-IV**:- Railway Recruitment Cell does not accept any responsibility for the candidates not being able to submit their application within the last day on account of aforesaid reasons or any other reason.

#### **10. DOCUMENTS TO BE UPLOADED:**

- 10.1 Scanned copy of certificate for proof of Date of Birth (Standard 10<sup>th</sup> /Matriculation Certificate/ Equivalent Educational Certificate / Educational Certificate indicating date of birth)/ Birth certificate in prescribed format issued by competent authority).
- 10.2 Scanned of Essential Minimum Prescribed Education Qualification mark sheet/certificate or its equivalent as prescribed in para 2 of the Notification.
- 10.3 Certificate regarding President Scout/Guide/Ranger/Rover OR Himalayan Wood Badge (HWB) Holder in any section.
- 10.4 Copy of certificate of two events at National level OR All Indian Railways' level
- 10.5 Copy of certificate of two events at State level.

- 10.6 Copy of certificate regarding active member of a Scouts organization for at least 5 years. The 'Certificate of Activeness' should be as per **Annexure-G.**
- Marks of Scouts & Guides certificates as prescribed will be awarded only on providing the original certificates as mentioned in the list on being declared pass in written examination)
- 10.8 Copy of No Objection Certificate (NOC) issued by their employer in case of serving employee.
- 10.9 Copy of caste certificate on the prescribed format for recruitment in Central Government services issued by the competent authority in the case of SC/ST/OBC for taking relaxation as admissible.
- 10.10 For taking relaxation as admissible, candidate belonging to Ex- Servicemen/Persons with Benchmark Disabilities (PwBD)/Minorities/ Economic Backward Classes should have to upload relevant certificate issued by the competent authority.
- **NOTE:-** No print-out/hard copy of application complete in all respect and/or SC/ST certificate needs to be sent to the office.

#### 11. Community Certificate:

- 11.1 The posts against Scout & Guide quota are open to all communities and there is no reservation for any community. Candidates belonging to SC/ST/OBC categories who apply against Scout & Guide quota will be extended relaxation in age limit as admissible in general open market recruitment.
- 11.2 Candidates claiming to belongs to SC/ST communities are required to obtain and upload Community Certificates from the competent Authority (Para-12) in the prescribed format (prescribed for Central Government employment) as per <a href="Annexure-A">Annexure-A</a> respectively and produce the original certificate at the time of DV, failing which he/she may be disqualified.
- OBC candidates are required to upload caste certificate with non-creamy layer certificate valid for the current year 2025-26 in Central Government format as per <a href="Manexure-B">Annexure-B</a> issued on or after **01.04.2025** by the Competent Authority (Para-12). Certificates should contain Caste, Date of Issue etc. and bear the Seal of the Issuing Authority

OR

OBC candidates who have applied for latest OBC certificate with latest Non Creamy Layer certificate are required to upload the existing OBC caste certificate in Central Government format (as per Annexure-B) issued by the Competent Authority (Para 12) and are also required to invariably fill and upload the Self-declaration form regarding current status of Non-Creamy-Layer (as per **Annexure-C**)

- 11.4 EWS(Economically Weaker Section) Reservation Candidates who are not covered under the scheme of reservation for SC/ST/OBC-NCL and whose family gross annual income is below Rs 8 Lakh (Rupees eight lakh) are to be identified as EWS for benefit of reservation for EWS. The income shall also include income from all sources i.e. salary, agriculture, business, profession etc. for the financial year prior to the year of application. For this financial year will be 2025-2026 as the closing date of registration is 24.09.2025. Also candidates whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of family income:
  - i. 5 acres of agricultural land and above;
  - ii. Residential flat of 1000 sq. ft. and above;
  - iii. Residential plot of 100 sq. yards and above in notified municipalities;
  - iv. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.

The term "Family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years.

The benefit of reservation under EWS can be availed upon production of an Income

and Asset Certificate issued by a Competent Authority {Para 12 (12.1) to (12.4)}. The Income and Asset Certificate issued by any one of the authorities {Para 12 (12.1) to (12.4)} in the prescribed format as given in **Annexure-F** shall only be accepted as candidate's claim as belonging to EWS.

The candidates applying against the vacancies reserved for EWS must produce valid Income and Asset Certificate issued by competent authority as per <u>Annexure-F</u> on the date of Document Verification. In case of non compliance to these stipulations, their claim for reserved status under EWS will not be entertained and the candidature /application of such candidates, if fulfilling all the eligibility conditions for General (UR) category, will be considered under General (UR) vacancies only.

**NOTE**:- For the purpose of para 10 and para 11 the latest instructions/Circulars issued by competent authority/department shall be applicable in the current Scout and Guide Quota of 2025-26 conducted by RRC/PRYJ.

- 12.4 Sub Divisional Officer of the area where the candidate and / or his/her family normally reside (s).
- 12.5 Certificates issued by Gazetted Officer of the Central or of a State Government countersigned by the District Magistrate concerned.
- 12.6 Administrator / Secretary to Administrator (Laccadive, Minicoy and Admindivi Islands).

#### 13. Medical Fitness:

Candidates recommended for appointment will have to pass requisite medical examination in the prescribed medical standard by Railway medical Authority to ensure that the candidates are medically fit to carry out the duties connected with the post. Visual Acuity Standard is one of the important criteria of medical fitness of Railway Staff.

**NOTE**:- Candidates qualifying in examinatin(s) for these posts but failing in prescribed medical examination(s) will not under any circumstance be considered for any alternative appointment.

#### 13. <u>INVALID APPLICATIONS/REJECTIONS:</u>

Candidates are requested to read all instructions thoroughly before submitting ONLINE application. Otherwise their applications are likely to be rejected on one or more of the following reasons. In case the application is rejected, candidates will be able to view their status ONLINE on the website of RRC along with the reasons for rejection(s). SMS and e-mail alerts shall also be sent to the candidates on their registered mobile numbers and e-mail IDs, if indicated in their ONLINE application. Candidates will not be intimated by post regarding the reason(s) of rejection.

- a. Application without signature or signature in Capital/Block or spaced out/disjointed letters.
- b. Application without Colour photo in uniform (or) photo wearing Goggles, (cap in S&G uniform also not allowed), disfigured, small size or unrecognizable or Photostat copy.
- c. Not possessing the prescribed Educational qualification.
- d. Not possessing the prescribed Scout & Guide qualification for the post(s) on the date of submission of application.
- e. Over-aged or under-aged or Date of Birth not filled or wrongly filled.

- f. Candidate's name figuring in the debarred list.
- g. Multiple applications for same post/category.
- h. Application without examination fee, (as applicable).
- i. Without certificate regarding active member of a Scouts organization for at least 5 years (or) certificate issued prior to the date of notification.
- j. In the event of any dispute about interpretation, the English version will be treated as final.

#### **GENERAL INSTRUCTIONS**

- 1. CANDIDATES TO ENSURE THEIR ELIGIBILITY BEFORE APPLYING: The candidates should ensure that they fulfill all eligibility conditions prescribed for the post/examination. Admission of the candidates for the written examination(s) for the posts notified in this notification would be on the basis of the information furnished by them in the ONLINE application. If at any stage of recruitment or thereafter, it is found that any information furnished by the candidate in his/her application is false /incorrect or the candidate has suppressed any relevant information or the candidate otherwise does not satisfy the eligibility criteria for the post(s), his/her candidature will be cancelled forthwith.
- 2. Before applying for any level, the candidates should ensure that he/she fulfills all the eligibility norms. The candidates should have the requisite Educational/Technical & Scout and Guide qualifications from the recognized Board Government University/ Institute/NCVT/SCVT as on the date of submission of the application. Those awaiting results of the final exams need not apply. RRC may reject the application of candidates at any stage of recruitment process in case the candidates are not fulfilling the requisite criteria and If appointed, such candidates are liable to be removed from service summarily.
- 3. Candidates who have been debarred for life from all RRB/RRC examinations or candidates who have been debarred for a specified period which is not yet completed need not apply in response to this employment notice. Their candidature will be rejected during any stage of recruitment as and when detected. If appointed, such candidates are liable to be removed from service summarily.
- **4.** Selection by RRC does not confer upon candidate any right of Appointment in the Railway.
- **5.** Selected candidates will have to undergo training wherever training is prescribed for the post.
- **6.** Emoluments on initial appointment will be minimum pay of the Level, plus other allowances admissible at that time. During training period only stipend will be paid as applicable. Candidates may have to give security deposit and execute indemnity bond wherever necessary.
