Ten posts of Deputy Mineral Economist (Intelligence) in the Level – 11 in the Pay Matrix (Rs. 67700-208700) in Indian Bureau of Mines under the Ministry of Mines is to be filled by deputation including short-term contract basis.

02. The duties in brief of Deputy Mineral Economist (Intelligence) in Indian Bureau of Mines are as under: -

"To supervise the work of Asstt. Mineral Economists and Mineral Officers related to collection, compilation, tabulation and analysis of data pertaining to mines, minerals, mineral based industries, exploration agencies, etc. for preparation of notes, reports, reviews, etc. for preparation of various publication like Indian Mineral Year Book, Bulletin on Mineral Information, Market Survey Reports, Consumption of Copper-Lead-Zinc, etc; preparation and periodical updation of NMI; for replying Parliament Questions, Ministry References and queries from general public; preparation and periodical updation of Directory of Mining Leases; matters related to Mineral Advisory Board."

- 03. As per the Recruitment Rules for the post of Deputy Mineral Economist (Intelligence), the candidates to be considered for appointment by deputation including short-term contract should be Officers under the Central Government or State Government or Union Territory Administration or Public Sector Undertaking or Universities or recognised Research Institutions or Autonomous Bodies or Statutory Organisations;
  - (A) (i) holding analogous post on regular basis in the parent cadre or Department; or,
    - (ii) with five years service in the grade rendered after appointment thereto on a regular basis in post in the Level -10 (Rs.56100-177500) in the pay matrix or equivalent; and,
  - (B) possessing the educational qualifications and experience as below:—
    - (i) Masters Degree in Geology or Applied Geology or Economics from a recognised University or Institute; or,
    - Bachelors Degree in Mining Engineering from a recognised University or institute;
    - (ii) Five years experience in the field of mineral economics, namely, conducting demand supply studies, market survey of minerals, mineral inventory, mineral legislation, world mineral intelligence, investigation of economic aspect of mineral resources and production and consumption or utilisation of minerals, analysis and dissemination of information;

Note-1: The Departmental officers in the feeder grade who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion

Note-2: Period of deputation (including short-term contract) including period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation or Department of the Central Government shall ordinarily not exceed four years.

Note-3: The maximum age-limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.
