Competent Authority has decided to hold a "Walk-in-Interview" for engagement of General Duty <u>Doctors and Specialist Doctors on contract basis.</u>

"Walk-in-Interview" will be conducted by East Central Railway for engagement of full time General Duty Medical Practitioner/Specialists for Central cum Super Specialty Hospital/Patna of East Central Railway. Willing Doctors who fulfill the qualification/eligibility criteria specified below may apply for the above engagement. The engagement will be purely on Contract basis for the period of one year which can be renewed as a fresh contract on year to year basis (not extendable beyond 20 years) or till the post filled by regular Doctors selected from UPSC or the scheme is available whichever is earlier.

1. General Duty Medical Practitioners (Full time)

Description of posts

(A) Vacancies : General Duty Medical Practitioners (Full time) -02 Nos.

(B) Qualification :

- (a) MBBS with 02 years experience preferably in critical care unit/Trauma/Emergency care unit.
- (b) Registered with Medical Council of India/Medical Council of State.

(C) Remuneration

Rs.95,000/ (Rupees Ninety five thousand only) per month, if Railway accommodation is not provided. If Railway accommodation is provided, deduction will be made from the monthly remuneration equivalent to House Rent Allowance payable on minimum pay to Junior Scale officer (Level-10 in 7th CPC) and fixed license fee for accommodation.

(B) Qualification

- (a) Degree/Diploma in corresponding specialty mentioned in above remarks column.
- (b) Should be registered with Medical Council of India/Medical Council of State.

(C) Remuneration :

Rs.1,23,500/ (Rupees One Lakh Twenty Three Thousand Five Hundred only) for the 1st Year; Rs.1,30,000/ (Rupees One Lakh Thirty Thousand only) for 2nd Year & onward per month, if Railway accommodation is not provided. If Railway accommodation is provided, deduction will be made from the monthly remuneration equivalent to House Rent Allowance payable on minimum pay to Senior Scale officer (Level-11 in 7th CPC) and fixed license fee for accommodation.

Note: In absence of specialists, all 05 nos. posts may be filled with GDMP with only MBBS degree with at least 02 years experience preferably in critical care unit/Trauma/ Emergency care unit.

- **6.** Retired IRMS officers, Retired Government Medical Officers of State Government and Central Government may also apply against above vacancies. The condition will be as under:-
 - (i) Age:- Not exceeding 67 years as on 24.09.2025.
 - (ii) Qualification:- Degree/Diploma in corresponding specialty mentioned in above remarks column and for GDMP- minimum qualification required is MBBS.
 - (iii) Remuneration:- The remuneration of retired Railway/Government doctors engaged as CMPs shall be subject to the condition that remuneration plus pension shall not exceed last pay drawn.

Application intending to join as Contract Medical Practitioner should apply on prescribed enclosed format and submitted the same up to 10.30 A.M on the date of interview at the venue along with self attested photocopies of following documents and attend the "Walk-in-Interview" with original certificates mentioned below –

- (a) Proof of age.
- (b) Proof of passing MBBS, Internship, Degree, Diploma & other educational certificate.
- (c) Proof of registration in Indian Medical Council/Medical Council of State.
- (d) Proof of caste in case of SC/ST candidate & creamy layer certificate in case of OBC candidate-(Only in prescribed format for Central Government will be accepted in case of OBC).
- (e) Proof of EWS certificate (Only in prescribed format for Central Government will be accepted in case of EWS).
- (f) Mark Sheet(s) of relevant qualification.
- (g) 04 (four) copies of passport size photograph with self signature.
- (h) Original Pension Payment Order book & self attested copy of the same in case of Retd. Doctor.

8. General Conditions and other facilities:-

- a. In the event of absence from duty, deduction from the remuneration will be applicable @ daily rate of proportionate of remuneration.
- b. Railway administration has legitimate right to transfer the engaged CMP(s) any where over E.C. Railway in case of administrative exigency.
- c. One set of 1st class complementary pass for self and family shall be issued during each contract period after completion of three months of regular contract service. Contract Medical Practitioner can avail free medical treatment on E.C. Railway Hospital for self only.
- d. No TA/DA will be paid to the candidates for attending the interview.
- e. Selected candidates will be posted in any Hospital/Health unit's of different Divisions of East Central Railway. The vacancies announced are only indicative and Railway reserve the right to make adjustments.
- f. CMP will have no right of posting against regular vacant post or transfer at his own request.
- g. CMP will not be allowed private practice after sanction of contract.

- h. The candidates working in any Medical Organization/State Govt. should submit their applications through proper channel with "No Objection certificate".
- i. Change of numbers of posts and place as specified above are subject to the condition. Offer of posting will be made on the basis of vacancies available at the time of engagement.
- j. Posts indicated herein may be kept unfilled at the discretion of Railway administration.
- k. Contract Medical Practitioners engaged on contract basis in the Railway will not have any claim or right for his/her continuity in service or automatic extension of the term of contract service rendered as a fulltime contract. The service rendered as CMP will not confer the right to take waitage for regular selection through UPSC and also will not confer any right for regularization or absorption.
- I. If Railway accommodation is provided to the CMPs subject to availability and after meeting the requirement of serving Railway officers, an amount equivalent to HRA payable to afresh entrant to Group 'A' Junior Scale/Sr.Scale and license fee of the Railway accommodation will be deducted from the monthly remuneration payable to the Contract Medical Practitioner.
- m. In case Specialists are not available against the vacancies as notified, Railway Administration will reserve the right to engage General Duty Doctors against these vacancies.
- n. Offer of engagement will be issued in favour of selected candidates; the candidates should report within 15 days from the date of issue of offer letter. The candidates not reported within stipulated time, offer may be treated as cancelled.
- o. Contract of the CMPs can be terminated by the Railway at any time during the contract period by giving 15 days notice without assigning any reason as per the terms and condition laid down in Railway Board's L.No:2007/H/1/1 dt-16.10.08; L.No:96/E(GR)II/9/16 dt-23.02.2000; L.No:2013/E(GR)II/1/5 dt-20.05.14 & Rly.Bd's L.No 2020/E(GR)II/1/3 dated-22.08.2025.
