- 1. Candidate have to mentioned post name on the envelope i.e. "Application for the post of Infection Control Nurse & Data Manager.
- 2. It is the sole responsibility of the candidate to track the application and the Dept of Microbiology, GMC, Chhatrapati Sambhajinagar is not responsible for any postal delay.
- The appointment will be purely on the contractual basis. Selected candidates will not be eligible for any benefits of the permanent Government employees or any teaching experience
- 4. Canvassing in anyway will lead to disqualification of the concerned candidate.
- 5. Candidate should possess required educational qualifications and/or experience required for the post.
- 6. The head of the department and the Dean will review the work of candidates appointed on the contract basis. If the review is unsatisfactory, the Dean reserves the right to terminate the appointment of a candidate without any prior notice.
- 7. Appointed candidate has to work full time under control of the head, department of Microbiology and the Dean, GMC Chhatrapati Sambhajinagar. The advertised posts are under the scheme for control of outbreaks and epidemic and hence the candidate may have to work in the affected areas in the vicinity as and when required during an epidemic.
- 8. The appointment will be purely on the contractual basis. The candidate has no right to claim for the regular appointment.
- 9. The selected candidates have to submit undertaking regarding acceptance of rules and regulations on Rs. 100 stamp paper duly notarized by an authorized notary. The candidate will also have to submit an undertaking on Rs. 100 stamp paper stating that will not approach the hon. Court for regularization of his service on the basis of the order issued for the above post.
- 10. Appointments will be given as per rules and regulation of the concerned authority. The candidate with higher qualification and experience will be preferred.
- 11. The candidates must possess computer knowledge. Possessing MS-CIT certificate is desirable.
- 12. No TA/DA will be paid for attending the interview. Interested candidates may appear for Exam/walk-in interview. Candidates should bring duly filled application form (As per the prescribed Performa) and all original certificates of educational qualifications, copies of research publications and experience certificate, identity proof, along with two photographs and two set of self-attested photocopies of all certificates and relevant documents at the time of interview.
