ELIGIBILITY (A OR B):

'A'

- (i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university. **(FOR DETAIL OF CONCERNED/ RELEVANT/ALLIED SUBJECTS PLEASE SEE APPENDIX-I-PAGE-5)**
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be, are exempted from NET.

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be Governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in the University subject to the fulfillment of the following conditions:

- (a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- (b) The Ph.D. thesis has been evaluated by at least two external examiners;
- (c) An open Ph.D. viva voce of the candidate has been conducted;
- (d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- (e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/ seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfillment of above conditions is to be certified by the Registrar/Controller of Examinations of the University,

NOTE: NET/SLET/SET shall also not be a requirement for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET,

The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

- (i) The Application Form for the above posts is to be filled only in the **Online Mode** at the Careers Portal of the University <https://careers.amuonline.ac.in>
- (ii) Separate Application forms are to be filled for each post detailed under a different Serial number of the advertisement.
- (iii) The **non-refundable Processing Fee** for each Application Form is **Rs. 500/-** and is to be paid only in the **Online Mode** at the Careers Portal. However, **PwD candidates are exempted** from payment of prescribed Processing Fee, in case they upload an authentic Disability Certificate on the prescribed Proforma with the Application Form.
- (iv) Applicants must follow all the instructions as given in the Advertisement and the User Manual available on the Careers Portal.
- (v) **After successful submission of the online Application Form, the applicant must:**
 - *Take the Printout of the PDF file of the Application Form on A-4 Size paper.
 - *Append his/her signature and paste front facing recent photograph at the designated place on the Application Form.
 - *Attach self-attested copies of all relevant documents including Receipt of processing fee, wherever applicable, with the Application Form.
- (vi) **Submit/Send the Application Form by post, complete in all respect, super-scribing on the top-left side of the cover, the post applied for, advertisement number and its date, "to the office of the Principal, Women's College, Aligarh Muslim University, Aligarh- 202002" on or before 23.10.2025 i.e. the last date of submission of the application form (Online Mode). The last date for submission of the hard copy of the online filled application form is 30.10.2025.**
- (vii) **The Self-Attested copies of the following documents are mandatory to be enclosed by the candidates with the employment application form:**
 1. High School Certificate from a Recognized Board.
 2. Mark-sheet and Degree of Graduation
 3. Mark-sheet and Degree of Post-Graduation
 4. Certificate of NET, JRF, SLET/SET, CSIR, etc., as the case may be.
 5. M.Phil./Ph.D. Degree wherever applicable.
 6. Experience Certificates wherever applicable.

NOTE: For Madarsa background applicants certificate equivalent to High School or Graduation will be considered if the same has been obtained from Madaris/Institutions recognized by the University.

In case, the self-attested copies of aforesaid documents are not enclosed with the employment form, the employment application form will be summarily rejected.

- (VIII) Incomplete Application Forms or applications on plain paper will not be entertained and shall be summarily rejected.
- (IX) Qualifications, experience, other eligibility conditions, etc. will be reckoned as on the last date of submission of Application Form.
- (X) The request for including any document(s)/information in the Application Form after the last date of submission shall not be entertained.
- (XI) The University reserves the right to alter/insert and/or make any corrections/ additions in the advertisement, or to cancel the advertisement (either in full or a part thereof) without assigning any reason. Amendment/Corrigendum, if any, in the advertisement shall be published only on the Career Portal.
- (XII) The number and nature of the posts may vary from the advertisement at the time of Interview.
- (XIII) The prescribed qualifications and experience are minimum and the mere fact that an applicant possesses the same will not entitle him/her for being called for interview. The University reserves the right to restrict the applicants to be called for interview to a reasonable number on the basis of Rules/Criteria or by any other condition that it may deem fit. The University may constitute a Committee to scrutinize the applications and short-listing the applicants.
- (XIV) In case of any inadvertent mistake in the process of scrutiny/selection which may be detected at any stage even after the issue of interview letter/appointment letter, the University reserves the right to modify/withdraw/cancel the selection process.
- (XV) The university reserves the right to get selected applicant examined by the Internal Medical Board.
- (XVI) The relaxation in the percentage of marks will be given as per the rule of the Government of India.

NOTE: A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Class (Non-Creamy Layer)/Differently-Abled ((a) Blindness and low vision; (b) Deaf and Hard Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing Good Academic Record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedures.
