- d. Preferable language known:- Bengali or Local vernacular Languages.
- e. Knowledge of Computer word, Excell Power Point and basic computer knowledge supported by course certificate.
- f. Preference will be given to community level personnel and female candidates.
- g. Should have clear and sound knowledge about functioning of SHG's / SHG based federation.
- h. Must have desire to learn new skill and acquire knowledge and is physically fit.
- i. Is willing to go outside block/ state / district as and when required.
- j. Must not continue to act as an employee or office bearer of any Upa Sangha / Sangha / Mahasangha.
- k. Can not continue to act as an employee or office bearer of PRI.

- m. Candidates from Locality (within district) should be preferred.
