Recruitment Notice

In reference to the letter of Mission Director, NHM vide memo no. HFW-27011/364/2021 NHM SEC Dept. of H&FW/3112 dated 25/09/2025, DH&FWS and Office of the CMOH, Purba Bardhaman is inviting online applications for engagement (on contractual basis) of **Community Health Officer (CHO)-Nursing (on contractual basis)** under NHM for Purba Bardhaman district.

A. Terms of Reference for engagement of B. Sc. Nurses with Integrated course of BPCCHN

1. Essential Criteria:

- (i) Passed Integrated course of BPCCHN included in B. Sc. Nursing in the year 2021 or thereafter from an institute recognised by West Bengal Nursing Council .
- (ii) The selected candidate will be posted as CHOs if she passed the Final year Examination conducted by University recognised by West Bengal Nursing Council.
- (iii) They must have registration certificate/ provisional certificate issued from West Bengal Nursing Council (WBNC).
- (iv) Proficiency in Bengali/ local language & dialect.

2. Desirable criteria: Competency in MS Office & Internet.

3. Mode of selection: The candidates will be selected through merit list based on **written test (85%) and interview (15%)**. The posting will be given after online counselling. The panel list will be valid for one year from the date of approval of panel.

4. The Consolidated Remuneration will be Rs.20, 000.00 per month.

In addition the CHOs will also get a maximum incentive of Rs 5000/ per month as PLI based on approved parameters.

5. If the incumbent proposes to give her work without covering 1(one) month's notice her remuneration will be adjusted accordingly.



B. Terms of Reference for engagement of General Nursing & Midwifery (GNM) /Post Basic B.Sc/ B.Sc. Nursing before the year 2021 Nurses for undergoing CPCH Training:

1. Essential Criteria:

- (i) The candidate must have Passed General Nursing & Midwifery (GNM)/ Post Basic B.Sc / B.Sc. Nursing before the year 2021 from an institute recognised by West Bengal Nursing Council.
- (ii) The must have registration certificate issued from West Bengal Nursing Council (WBNC).
- (iii) Proficiency in Bengali/ local language & dialect.

2. Desirable criteria: Competency in MS Office & Internet

3. Mode of selection: The candidates will be selected through merit list based on **written test (85%) and interview (15%)**. The panel list will be valid for one year from the date of approval of panel.

4. The Consolidated Remuneration will be Rs.20, 000.00 per month after posting in Susathya Kendra.

In addition the CHOs will also get a maximum incentive of Rs 5000/ per month as PLI based on approved parameters.

5. During their training period they will get Rs. 10,000.00/ per month as stipend.

6. The candidates shall serve in Susasthya Kendra as CHO after successful completion of training, for which they have to sign a bond agreement. In case they **fail** to serve the bond period, they will have to pay Rs. 2 lakhs .

Applicants for EWS(E.C) categories may take note of the provision on para 7 of Gazette Notification, published by Labour Department, Gov. of W.B., vide no. Labr/110-Emp/EC/1M-01/2025 dated 13/06/2025, wherein it has been stated inter alia that " Appointing authority should obtain names from Exempted Category cell under the Directorate of Employment, West Bengal, to fill up the vacancies meant for Exempted Category Candidates in the above roster..."

For the above mentioned posts, desiring candidates will visit **www.wbhealth.gov.in.** / online recruitment to fill up online application. **Last date to fill up the online application is on 24/12/2025.**

An application fee of Rs. 100/-(Rs.50/- for reserved categories) will be deposited to the Bank through NEFT in favor of DISTRICT HEALTH AND FAMILY WELFARE SAMITY (NON-NHM) Bank A/C No-0187132000008, IFSC- CNRB0000187. Bank deposit copy (with UTR no.) will have to be submitted with printed copy of the on-line application form, during checking and verification.

Online payment will also be accepted. In that case receipt or screen shot of payment will have to be submitted with printed copy of the on-line application form, during checking and verification.

General Information for the Applicants/Candidates:

- i) The applicant must be a permanent resident of West Bengal.
- ii) The applicant must have knowledge of local languages (should be able to read, write and speak in Bengali).
- iii) Age relaxation will be given for the reserved candidates as per existing norms of the State Government.
- iv) Only online Applications will be accepted. Application forms not properly filled in or incomplete Application forms are liable to be cancelled. If online application details submitted by the applicant differ with the original testimonials, same application shall be liable to be cancelled.
- v) If proper signature and photograph are not uploaded at the time of submission of online application such application shall also be liable to be cancelled.
- vi) Hard copy/print copy of the online registration form may be downloaded from the link "<https://hr.wbhealth.gov.in/Index.aspx>" -> "Application Print" and should be retained by all the applicants for document verification purpose. Without registration form, candidates will not be entertained for original testimonials verification by the authority. No need to send Hard copy/print copy of the online registration form by post.
- vii) The Essential Criteria mentioned are the minimum and mere possession of the same does not entitle the candidate to claim selection. All the essential academic qualification must be completed on or before the last date of online application.
- viii) The candidates, if found ineligible at any stage of recruitment process, will not be called for the subsequent stages of the selection process.
- ix) The eligible candidates will have to go through all stages of recruitment. If a candidate skips any stage(s), s/he will be disqualified without any further communication.
- x) The above-mentioned post is purely contractual in nature with initial period of engagement up to March'2026 and may be renewed for further period depending on satisfactory performance and approval of higher authority.
- xi) If the incumbent proposes to give her work without covering 1(one) month's notice her remuneration will be adjusted accordingly.
- xii) The decision of the competent authorities regarding the recruitment is final.
- xiii) The competent authorities may cancel the recruitment process at any stage of the selection process.

On the basis of on-line application data, a provisional list will be prepared for original testimonial verification.
