An application fee of Rs. 100/- (Rs.50/- for reserved categories) will be deposited to the Bank through NEFT in favor of DISTRICT HEALTH AND FAMILY WELFARE SAMITY (NON-NHM) Bank A/C No- 0187132000008, IFSC- CNRB0000187. Bank deposit copy (with UTR no.) will have to be submitted with printed copy of the on-line application form, during checking and verification.

Online payment will also be accepted. In that case receipt or screen shot of payment will have to be submitted with printed copy of the on-line application form, during checking and verification.





If the message “**Duplicate Registration !**” appears during online application (for the candidate, who have applied before for the same post), please enter your last name two times in the “* **Enter Last Name:**” field of first page of online application form. Final correction will be done during checking verification of application with original documents.

General Information for the Applicants/Candidates:

- i) The applicant must be a permanent resident of West Bengal.
- ii) The applicant must have knowledge of local languages (should be able to read, write and speak in Bengali).
- iii) Age relaxation will be given for the reserved candidates as per existing norms of the State Government.
- iv) Only online Applications will be accepted. Application forms not properly filled in or incomplete Application forms are liable to be cancelled. If online application details submitted by the applicant differ with the original testimonials, same application shall be liable to be cancelled.
- v) If proper signature and photograph are not uploaded at the time of submission of online application such application shall also be liable to be cancelled.
- vi) Hard copy/print copy of the online registration form may be downloaded from the link “<https://hr.wbhealth.gov.in/Index.aspx>”-> “Application Print” and should be retained by all the applicants for document verification purpose. Without registration form, candidates will not be entertained for original testimonials verification by the authority. No need to send Hard copy/print copy of the online registration form by post.
- vii) The Essential Criteria mentioned are the minimum and mere possession of the same does not entitle the candidate to claim selection. All the essential academic qualification must be completed on or before the last date of online application.
- viii) Selection will be made on the basis of marks obtained in Academic qualification / Experience.
- ix) All marks must be calculated excluding marks of Additional Subject. No rounding off of marks will be granted. Proportionate marking up to 2 decimal points will be considered.
- x) Experience will be calculated after obtaining the required essential academic qualification for the above-mentioned position, till the last date of online application with supporting documents of Experience Certificate. Experience certificate must consist of Name of the post, Employer’s Name, Employee’s Name, Date of Joining, Date of Leaving, otherwise experience certificate will be treated as invalid. No appointment letter will be treated as experience certificate.
- xi) In case of experience from Private Org., the selection committee may ask for salary statement/ appointment letter or any other documents from the agency for the said period for verification.
- xii) The candidates, if found ineligible at any stage of recruitment process, will not be called for the subsequent stages of the selection process.
- xiii) The eligible candidates will have to go through all stages of recruitment. If a candidate skips any stage(s), s/he will be disqualified without any further communication.
- xiv) The above-mentioned post is purely contractual in nature with initial period of engagement up to March’2026 and may be renewed for further period depending on satisfactory performance and approval of higher authority.
- xv) The decision of the competent authorities regarding the recruitment is final.
- xvi) The competent authorities may cancel the recruitment process at any stage of the selection process.

On the basis of on-line application data, a provisional list will be prepared for original testimonial verification. Print copy of online application form, NEFT documents /receipt/ screen shot of payment (for online payment) and other supporting documents in favour of age proof, caste, educational qualification etc. will be verified.
