The above posts are unreserved.

Age Limit: 18 to 45 years as on 01-12-2025. The upper age limit is relax able by five years in case of candidate belonging to SCs, STs, OBCs, persons with disabilities widow, divorcee, ex-service man of Himachal Pradesh.

Application Fee: Rs.200/-. The fee should be paid through demand draft only in favor of Chairperson, Indian Red Cross Society, District branch Kullu payable at Punjab National Bank, Dhalpur Branch Kullu. The fee is non-refundable.

How to apply:

- (1) The candidate applying for the post must ensure that he/she fulfill all eligibility conditions as prescribed above against each post. Incomplete/ineligible application will be rejected straight way and no correspondence will be entertained.
- (2) The candidate will be required to submit application on the prescribed format as per Annexure- I along with demand draft and self-attested photo copies of educational qualification to the Secretary, Indian Red Cross Society, District branch Kullu DC Office Complex, Kullu- 175101 (Himachal Pradesh).

Selection Procedure:

- (1) In case the number of **eligible candidates are less than three for a post, only personal interview of 25 marks will be conducted** on basis mentioned below :-

** experience certificate of only those candidate will be considered who remained on the payroll of government/semi-government or registered organization.

- (2) In case the number of **eligible candidate are more than three, the candidates will be required to appear in the screening test of 25 marks having multiple choice questions from the related field and interview etc. of 25 marks.**
- (3) Merit list for each post will be drawn on the basis of marks obtained in the screening test /interview and the candidate will be selected on the basis of merit.

Terms & conditions:

- (1) The recruitment authority reserves the right to change any of the term of the advertisement or to rectify the inadvertent/technical error in any stage.
- (2) No TA/DA will be given to the candidates appearing for screening test/interview.
- (3) The services of appointee shall be co-terminus with the grant in aid received from the Government of India/ State Government or as long as the post remains under

the scheme or the terms and condition/ eligibility criteria for the post is not revised.

- (4) The recruitment of the selected candidate will purely on temporary basis and does not confirm any right, claim for permanent absorption, regularization in Indian Red Cross Society District Branch, Kullu. Only honorarium will be paid and no other allowances of any kind shall be admissible.
- (5) The appointee shall be on annual contract basis initially from the date of joining of the post and the contract shall automatically stands terminated on the completion of contractual period of one year. The appointee may leave the contract by giving one month's notice or one month's honorarium in lieu of notice.
- (6) The appointee shall have to perform the duties as per job responsibility attached with the post. The appointment is liable to be terminated at any time without assigning any reason in case of non-performance and conduct of the appointee. Any sort of insubordination in discharge of duty shall entail immediate discharge from service.
- (7) The contract can be reviewed thereafter on yearly basis depending upon the satisfactory performance and overall conduct.
- (8) The appointee shall have to perform the duties as per the provisions of the scheme or as notified from time to time and directions issued by the Indian Red Cross Society, District Branch, Kullu.
- (9) The appointee shall have no right to claim for enhancement of honorarium at par with other similar posts under government or private sector at any stage.
- (10) The appointee shall be entitled to 12 days casual leave, and other gazetted holidays during the calendar year. In case the services of appointee are required on any Sunday or holiday, he/she shall be bound to attend the office and nothing will be paid for such duties except compensatory off. The un-availed leave shall not be carried forward to the next year.
- (11) Unauthorized absence from duty without prior approval of controlling officer shall automatically lead to the termination of services and the appointee shall not be entitled for honorarium during the period of absence from duty.
