The Computer Test of the selected candidates for the post of "Protection Officer (Non-Institutional Care)" will be held on the basis of marks obtained in Written Examination. The list of successful candidates of Written Examination, who will be selected for Computer Test will be notified in the Website (https://bankura.gov.in) in due course.

Viva-Voce of the selected candidates for the post of "Protection Officer (Non-Institutional Care)" will be held on the basis of total marks obtained both in Written Examination and Computer Test whereas Viva-Voce of the selected candidates for the post of "Outreach Worker" will be held on the basis of marks obtained in Written Examination.

E. Mode of Application:

- 1. All applicants shall apply by submitting scanned copy (at least 300 dpi) of filled up and signed application form with pasting recent (not older than 6 months) colour passport size photograph along with relevant self-attested scanned documents to the dedicated e-mail Id given in this notice only.
- 2. There shall be no provision of receiving of hard copy of application form.
- 3. Application once submitted shall be treated as final. No request for change in application form will be entertained after submission of the application.

F. Grounds of rejection of application form:

- 1. A candidate can apply for only one category of the post. Multiple applications for a single post or more than one post is strictly forbidden and will lead to rejection of the candidature in all the posts applied.
- 2. An application form submitted without signature or photograph or both and without submitting of relevant documents shall be rejected.
- 3. Applications incomplete in nature shall be rejected.

G. Issuance of Admit Card:

- 1. Admit card will be sent through the above mentioned email Id of the authority. The applicant will have to take a printout of the Admit card from the mail. Admit cards may also be collected from the office of the DSWO, Bankura on notified date if the candidates does not avail Admit Card through email. Notification will be done in due time on the website:https://bankura.gov.in.
- 2. Two (2) copies of recent Passport size Photograph duly self-attested to be fixed on the Admit card in the place earmarked for the purpose.
- 3. The lower part of the Admit Card is to be signed by the applicant in presence of the invigilator on the day of examination and to be handed over to the invigilator.
- 4. The candidates shall have to bring with him / her any Photo Identity documents like EPIC / Passport / AADHAAR / Admit Card / PAN Card / Driving License / any other Identity card issued by the competent Govt. authority along with the Admit Card on the day of written examination in the examination hall.
- 5. Candidate without Admit Card and Photo Identity documents shall not be allowed to enter the examination hall.

H. General terms and conditions:

- 1. Age of the candidates will be calculated as on 11.12.2025 as recorded only in the Madhyamik or equivalent examination or in Birth Certificate.
- 2. The shortlisted candidates for Computer Test for the post of "Protection Officer (Non-Institutional Care)" and the shortlisted candidates for Viva-Voce for the post of "Outreach Worker at DCPU" will be asked to produce all relevant original documents at the time of Computer Test and Viva-Voce respectively regarding Identity, residence, age, educational qualifications and experience along with their self attested photo copies, failing which their candidature shall be rejected. The self-attested photocopies of relevant documents have to be submitted at that time.
- 3. In any stage if any statements made in the applications is found to be false, his / her candidature will liable to be cancelled, even if appointed to the post on the basis of result of his / her examination. His service will be terminated and legal action as per law will be initiated against him / her. Willful suppression of any fact will also be similarly dealt with.
- 4. Use of Mobile Phone, Calculator and any kind of electronics gazette inside the examination hall is strictly prohibited. Use of the same will lead to cancellation of Candidature without giving an opportunity of being heard.
- 5. Canvassing in any form will disqualify the candidate.

- 6. The District Selection Committee reserves the right to suspend / postpone any process related to this Notification at any stage.
- 7. The final merit list will be prepared on the basis of total marks obtained in the Written Examination, Computer test (where applicable) and Viva-Voce.
- 8. If any change takes place in the date and time of examination, eligibility criteria, syllabus for examination, vacancy position or any other issue related with this notification will be brought to the notice of the candidates through District's Website.
- 9. If any person has been terminated at any time from Govt. Service (permanent / contractual / part time) due to dissatisfactory performance or otherwise, he / she will be ineligible for this post and his / her application will summarily be rejected.
