Applications are invited from the eligible female candidates for the post of Accredited Social Health Activist (ASHA).

A. PERIOD OF RECEIVING APPLICATION:

From 16.01.2026 to 27.01.2026 up to 12o'clock midnight.

B. SELECTION CRITERIA:

As per Memo. No. HWF/NHRM-20/206/(Part-II)1631 Dated 27.06.2012 of Govt. West Bengal, Health & Family Welfare Department (NHRM) and as per resolution made in the ASHA Selection Committee dated-14.11.2025.

- Selection is based on marks obtained by the candidates in the Madhyamik/ equivalent examination (without additional subjects) (90% weightage).
- Score in the interview (10% weightage).
- Experience certificate, from competent authority (BDO/BMOH) in case of Grade-I & Grade-II SHG members/trained dais/Link workers. (If any).

C. ELIGIBILITY:

1. Candidate should be married, divorced or widowed woman (Certificate from competent authority).
2. Candidate should be a resident of the same service villageshould be matched with part no. Mentioned above for which she will be selected. Ration card or EPIC or Certificate of Gr-A officer in this regard is mandatory to proof residential qualification.
3. Applicant shall have to submit **Electoral Photo Identity Card** at the time of online application mandatory.
4. Candidate should be within the age group of 30-40 years. In case of SC and ST candidates, the lower age limit is relaxed to 22 years (Caste certificate is mandatory for age relaxation). In both cases age of the applicant means her age **as on 01.01.2026**.
5. Candidate should be at least Madhyamik passed or appeared or equivalent. [from a board/council/institution/university, recognized/affiliated/registered by the Government of India or Government of states.]
6. Only marks obtained in Madhyamik or equivalent examination without additional subject(s) will be considered.
7. Candidate possessing SC/ST certificate from other state will be treated as unreserved category.

D. MODE OF APPLICATION:

1. Candidates should submit application through Online mode only via URL <https://opportunity.maldadistrict.in/> then click to "ASHA Online Application System, Chanchal Sub-Division" available at recruitment TAB at www.malda.gov.in.
2. Candidate may collect information and assistance in filling up the Application Form from their respective Health Sub Centers / BPHC/RH.
3. One candidate should submit one application. More than one application shall cause cancellation of all the applications submitted by one candidate.

E. DOCUMENTS TO BE REQUIRED AT THE TIME OF SCRUTINY-DOCUMENT VERIFICATION AND INTERVIEW:

(Candidate must carry self-attested Photo copy of following documents along with original)

1. EPIC/ Voter's Identity Card of the candidate.
2. Admit Card of Madhyamik or Equivalent Examination for proof of age.
3. Marksheets of Madhyamik or Equivalent Examination.
4. Caste Certificate only for age relaxation (for SC/ST category).
5. Experience certificate from competent authority (BDO/BMOH) in case of Grade-I & Grade-II SHG member/trained dais/Link worker.

6. Two copies of Recent Passport Size Photographs.
7. Preference would be given to the SC/ST and Grade-I/Grade-II SHG members and Trained Dais and Linked Workers according to the prescribed guidelines as cited before. This preference implies that priority of an applicant over other(s) if two/ more than two applicants get the same score after final tabulation. Preference for SC/ST indicates age relaxation according to afore mentioned ASHA recruitment guidelines and also priority for an applicant for such service village where SC/ST concentration of population is higher than Unreserved population. As there is no mention of OBC in ASHA recruitment guidelines so there would not be any preference in this category. The certification of these aforesaid qualifications should be obtained from competent authorities like SDO/BDO/BMOH where it deems appropriate.

F. GENERAL CONDITIONS:

1. Candidates, before applying, should carefully read the instructions and ensure fulfillment of the eligibility-criteria at the time of submission of application.
2. Submission of application does not guarantee an appointment.
3. Candidates shall be disqualified at any time and at any stage during the selection process, in case of any misrepresentation of facts and documents. Appropriate legal action may be taken against such candidate.
4. Chanchal Sub Divisional Level ASHA Selection Committee, Malda reserves the right to alter the modes of examinations or conduct, re-interview or cancellation of part or whole of any process of recruitment at any stage.
