If the last date fixed for receipt of applications happened to be holiday, then the applications shall be received on next working day.

2. The applications received after the last date will not be entertained. The University shall not be responsible for delay in receipt of applications due to any reasons what

3. The candidates must ensure their eligibility in respect of category, essential qualification(s) etc. as mentioned against concerned post in the advertisement to avoid rejection at later stage.

4. A candidate shall be eligible for appointment to above post, if he/she has passed Matriculation and 10+2 from any School/Institution situated within Himachal
