Age Limit: Between 21-30 Years

The candidates willing to appear in the above said **walk-in-interview** must fill the **Online Google Form by last date i.e 09 December 2025** and bring your brief bio-data in the proforma attached along with certificate of age, qualification, experience and caste, completed in all respects. The document verification will be done on the same day of interview at AIIMS, Bathinda followed by interview of eligible candidates only on the same day.

- I. The interview may also be extended to the next day, if the number of applicants is more. Hence, kindly prepare yourself and plan your journey accordingly. No TA/DA or accommodation will be provided for attending the interview.
- II. Inadequately filled/ incomplete application form may be summarily rejected and no enquiry or representation will be entertained in this regard.

Process to apply:

The aspiring applicants satisfying the eligibility criteria, in all respects, can fill the application form attached with this advertisement and bring the attested copies of certificates in support of date of birth, educational qualification, experience, caste certificate & other relevant documents, proof of application fees paid etc. on the day of Walk-In-Interview.

Important Instructions:

- •All original documents to be brought on the date of interview as mentioned in para 2 below (no need to send the hard copy).

GENERAL INSTRUCTIONS:-

1. Age Limit:

Cutoff date to determine eligibility in terms of upper age limit and all other qualifications and experience of candidates will be the last date of submission of google form in the link mentioned in the application process i.e., 09 December 2025.

- (i) The upper age limit is relaxable to 5 years for SC/ST candidates, 3 years to OBC candidates and 10 Years for Persons with Benchmark Disability.
- (ii) **To be eligible for selection** for these posts, the candidate should possess the essential qualification and experience on 09 December 2025 will be considered.
- (iii) The candidates who are in service in any Government Institutions are required to submit **No Objection Certificate** from the present employer at the time of Interview.
- (iv) No age relaxation will be available to reserved category candidates applying for unreserved vacancy.

- (v) Age relaxation will be regulated as per the instructions issued in this regard by Department of Personnel and Training from time to time.
- 2. On the day of Interview, the candidate is required to be present 'in person' with all original certificates at Ground Floor, Admin Block, Medical College Building, AIIMS Bathinda along with:
 - (i) Residence Proof.
 - (ii) Age Proof.
 - (iii) Qualification proof. (as mentioned in Essential Criteria)
 - (iv) NOC document. (if applicable)
 - (v) Age Relaxation Document (if applicable)
 - (vi) Experience certificate.
 - (vii) Caste certificate in Central Government format.
 - (viii) Proof of Application fee paid.
 - (ix) Any other relevant document in support of your candidature.

Note: Self attested copy of the above-said documents is required to be attached with the application form.

3. Application Fee (Non-Refundable):

The Candidates will be required to pay prescribed Application Fees through Online Mode only via Payment Gateway's Link mentioned below.

Note:

Candidates belonging to OBC/ SC/ ST category can still apply for the aforementioned post but they will not be eligible for any concession/relaxation etc.

The transaction reference number and the date of transaction should be mentioned in the application form. No application fee is applicable for Persons with Benchmark Disability (PwBD) candidates. **The fee once remitted will not be refunded under any circumstances or adjusted.** Applications without the prescribed fee will not be considered and summarily rejected.

4. Selection Procedure:

The selection will be on the basis of the interview and if, the large number of candidates will apply for the post then the written exam may be conducted for shortlisting for the interview or any other method found suitable by the competent authority. The prescribed qualification is minimum requirement and mere possessing the same does not entitle any candidate for selection. Candidates are requested to visit AIIMS, Bathinda website regularly for updates regarding recruitment/selection process.

5. **Tenure & Expiry of Contract:**

The appointment is purely on contract basis initially for a period of 179 days and extendable up to a maximum of two years or till regular appointment is done against this post, whichever is earlier. This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in the Institute OR for continued contractual appointment, which may be renewed or terminated as per policy/rule/need of the Institute. However, the contractual appointment shall not be extended beyond the period of two years and if the contract is not extended further, the same will lapse automatically. The appointee can also leave the Institute by giving One months' notice or by paying salary in lieu of this notice period or for the period of which notice falls short of one month

6. Remuneration:

Consolidated remuneration shown against this post shall be given to contractual appointee after statutory deductions. The appointee shall not be entitled to avail any allowances/facilities being extended to the regular/permanent staff of AIIMS Bathinda.

- 7. The appointee shall not be entitled to any benefit like Government Accommodation, Provident Fund, deduction of NPS Subscription, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the government servants, appointed on regular basis.
- 8. The appointee shall be a whole-time employee of the Institute and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period.
- 9. The appointment to the said post will be subject to medical fitness from the competent Medical Board, for which he/she shall be sent to the designated medical board of the AIIMS, Bathinda.

10. **Leave:**

The leave entitlement of the appointee shall be governed by the Institute's leave rules as amended from time to time.

- 11. The competent authority reserves the right to change the number of vacancies, withdraw the process in full or in part and also the right to reject any or all applications received without assigning any reasons or giving notice etc.
- 12. Canvassing of any kind will lead to disqualification.
- 13. The candidate may have to work in shifts and can be posted at any Place/Department of the Institute.
- 14. No travelling or other allowances will be paid to the candidate for Interview/Joining for the post.
- 15. The candidate should not have been convicted by any Court of Law.
- 16. On appointment, the appointee will be required to take an "**Oath of Allegiance**" to the Constitution of India or make a solemn affirmation to that effect in the prescribed proforma.
- 17. Other conditions of service will be governed by relevant rules and orders issued by Govt. of India from time to time with regard to contractual employees.
- 18. The decision of the Competent Authority regarding selection of the candidate will be final and no representations will be entertained in this regard.
- 19. All information pertaining to this advertisement including date of interview, notices, results, etc. will be displayed on the AIIMS Bathinda website (https://www.aiimsbathinda.edu.in). No individual intimation will be sent by AIIMS Bathinda to applicants. It will be the responsibility of the applicants to keep in-touch of the institutional website for development by visiting website regularly. Any corrigendum or revision of the advertisement or any other information regarding this recruitment will be posted on the Official Website of AIIMS, Bathinda only in due course of time.
- 20. All disputes will be subject to jurisdictions of Court of Law at Bathinda only.
- 21. The candidates must ensure that they fulfill eligibility criteria. If at any stage, it is found that the candidate has furnished any incorrect information his/her candidature will stand cancelled. If any shortcoming(s) is/are detected even after the appointment, his/her services will be summarily terminated. Candidates are advised to satisfy themselves before applying that they possess at least the essential qualification laid down for these posts. No enquiry for advice as to eligibility will be entertained.
- 22. Interim correspondence will not be entertained and replied to.
- 23. All the original certificates/documents will be verified before the time of interview.

- 24. The period of experience, wherever prescribed, shall be counted after obtaining the prescribed qualification. For posts having experience as an Essential Criteria, the experience which has been acquired only after obtaining Essential Qualification, will be considered as valid.
- 25. In case, any mistake in selection process is detected, the institute reserves the right to modify/withdraw/cancel any communication made to the candidates.
- 26. The candidates are advised to visit the institutional website for any additional information and for confirmation about the date and time/ venue of the Interview before coming. No personal / by post information will be sent.
