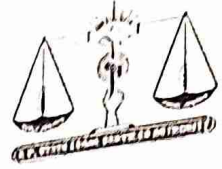

1. The applicant must be citizen of India ;
2. Age of applicant must be below 65 years as on 01-12-2025 ;
3. Application in prescribed form annexed herewith shall reach the Office of Andhra Pradesh State Legal Services Authority on or before 5.00 P.M. on 26.12.2025. The Authority shall not be responsible for delay caused by Post Office delivery ;
4. The application must accompany self addressed envelope with postal stamps of Speed Post and self attested certificates of experience if any and self attested matriculation certificate. These papers shall be subject to verification at the time of Interview ;
5. Interview of candidates shall be taken by Hon'ble Executive Chairman or person/persons authorised by Hon'ble Executive Chairman. Candidates who have worked with Legal Services Authority with satisfactory performance may be given preference ;
6. Decision of Hon'ble Executive Chairman, APSLSA shall be final about selection and posting ;
7. The A.P. State Legal Services Authority shall have right to cancel or modify the notification or to accept or reject any candidature without assigning any reasons with the approval of the Hon'ble Executive Chairman, APSLSA;
8. The Members shall hold Office for a maximum term of five years or till attaining the age of 65 years whichever is earlier and shall not be eligible for re-appointment ;
