- 4.1 **Scrutiny of Applications.** All applications received from the candidates will be scrutinized subject to the eligibility criteria and necessary documents and the admit cards will be issued to the shortlisted candidates for document verification & appearing in the written examination.
- 4.2 **Document Verification.** All the shortlisted candidates will undergo document verification prior appearing in the written examination. Candidates will be required to bring their original documents and self-attested photo copies (02 sets) of the same as per the directives/ instructions given in their admit cards.
- 4.3 **Written Examination.** All the shortlisted candidates will undergo written examination on the basis of educational qualifications prescribed for the post. The written examination will be pen-paper based and one hour duration. The Question Paper (bilingual) for written examination will consist of 80 objective type questions with one mark for each correct answer and there will be no negative marking.

- 4.6 Merit list will be prepared strictly based on merit position as per marks obtained in written examination and will be published on the Indian Coast Guard website alongwith necessary instructions.

5. Important Instructions to Candidates-

- 5.1 Before applying for the post, the candidates should ensure that he/she fulfils the eligibility and other norms mentioned in the advertisement.
