Publication Requirements:

Candidates applying for faculty position should have strong research credentials through publications in ABDC or ABS ranked journals.

Note: For applicants in Business Communication, apart from ABDC/ABS journal ranking, SCImago Journal Rank Indicator (Quartile) would also be considered.



General Instructions:

- 1. Reservation will be applicable as per Government of India norms.
- 2. Candidates are advised to visit the website of IIM Tiruchirappalli (www.iimtrichy.ac.in/careers) regularly for updates. Amendments, corrigenda (if any), will be placed on the Institute website only.
- 3. Interested candidates who fulfil the minimum eligibility criteria and publication requirement should apply online only through the Recruitment Portal in the Institute website www.iimtrichy.ac.in/careers.
- 4. A candidate can apply for only one position (Professor or Associate Professor or Assistant Professor Grade I) in only one specialization.
- 5. Qualifications acquired must be duly recognized by law. All qualifications from India must be from UGC recognized University/ Deemed University or AICTE approved autonomous institution (wherever applicable).
- 6. Applicants should satisfy the experience criteria as on the last date of receipt of applications.
- 7. Applications received through the online portal *only* will be considered.
- 8. Applications should be complete in all respects. All information furnished MUST be based on supporting documentation. Incomplete/incorrect/sketchy applications are liable to be rejected.
- 9. The Institute follows the Reservation Policy as per Govt. of India rules. Therefore, candidates applying under SC (Scheduled Caste), ST (Scheduled Tribe), OBC-NCL (Other Backward Class- Non Creamy Layer), PwBD (Persons with Benchmark Disability) or EWS (Economically Weaker Sections) category are required to select the relevant category while applying in the Recruitment Portal and will also be required to upload the relevant valid certificate in support of their claim for the category. The physical copy of the same should be produced, if called for selection process.
- 10. The candidates are required to submit the Caste/ Category/ Disabilities Certificate issued by the Competent Authority in the format prescribed by the Government of India for this purpose.
- 11. The last date of receiving applications against this advertisement is **November 21, 2025** at **5.30 PM**.
- 12. Mere fulfilment of qualifications and experience does not entitle a candidate to be short-listed. The Institute reserves the right to restrict the candidates to be called for the selection process to a reasonable number based on relevant criteria, higher than the minimum prescribed.
- 13. The Institute will communicate only with shortlisted candidates. No correspondence from applicants shall be entertained.
- 14. Canvassing in any form will be a disqualification.
- 15. Applicants are required to bring with them all the original certificates, testimonials and other relevant documents for the selection process, if shortlisted. Candidates who fail to produce all original certificates as stated in the application, will be rejected from further



selection process.

- 16. Applicants who are employed in Government, Semi-Government Institutions on regular position (including those on probation) should produce a NO OBJECTION CERTIFICATE from their current employer at the time of selection process, if shortlisted.
- 17. The Selection Committee may recommend candidates for appointment in different positions other than the actual position applied by the candidate either on regular basis or on contract basis.
- 18. Candidates who have attended the interview with us for the selection process in response to our recruitment notification Ref. No.EST-I/A-02/2025/001 dated 18.04.2025 during the Calendar year 2025 need not apply.
- 19. Initial pay and level would be decided based on qualification and experience of deserving candidates.
- 20. Candidates must produce a Relieving Letter from the previous organisation at the time of joining, if selected.
- 21. The Institute reserves the right not to fill up any / some / all position(s).
- 22. The shortlisted applicants for the Interview will be reimbursed for the travel expenses (Shortest Fare Air (economy)/Train (II AC)) upon the submission of the relevant documents. Mode of Selection:
