- (i) Minimum 4 years of post PGDM/MBA relevant experience in the Power Sector, specifically in Business Development/Marketing/Strategic Planning in the international domain.
- (ii) Preference may be given to candidates having Proficiency in MS Excel, PowerPoint, Word, SAP, and other relevant tools
- (iii) Preference may be given to candidates having prior experience in drafting and negotiating Memorandums of Understanding (MoU), Non-Disclosure Agreements (NDA), Contract Agreements etc.

Hence, all applicants are advised to go through the medical norms before applying.

## **GENERAL CONDITIONS:**

- 1. Only Indian Nationals are eligible to apply.
- 2. All qualifications should be from Universities / Institutions recognized and approved in India. SC/PwBD candidates with passing marks in the qualifying degree are also eligible to apply for the post.
- 3. All computations of age/ experience requirement / qualification etc. shall be done w.r.t. the last date of receipt of online application as mentioned in the advertisement.
- 4. The category once filled in the online application form cannot be changed and no benefit of other category will be admissible later. Candidates claiming to belong to a particular category should necessarily have the valid EWS/OBC/SC/ST/Disability certificate, as the case may be, from the Competent Authority (in the latest prescribed format of Govt. of India). Where there is a vacancy identified for such category, The upper age limit will be relaxed by 5 years in case of all cadres/groups for SC/ST categories, by 3 years for OBC Categories and by 10 years for PwBD categories. Relaxation of age to ExServiceman will be as per Govt. guidelines. Total required experience will be relaxed by 01 year for SC category.
- 5. Depending on the requirement, the Company reserves the right to cancel / restrict / curtail / increase the number of vacancies, if need arises, without any further notice and without assigning any reason thereof.
- 6. In-order to restrict the number of candidates for further selection process, if so required, the management reserves the right to conduct multi-stage selection process which may comprise of application shortlisting/screening (based on qualification/percentage of marks, no. of years of post qualification experience etc.), written/computer-based test, personal interview etc. or combination of the above or to raise the minimum eligibility standards/ criteria, as per requirement.
- 7. It is pertinent to mention that the mere fact that a candidate is fulfilling the minimum eligibility criteria as prescribed in the advertisement would not bestow on him/her the right to be shortlisted/called for written test/Interview or to be considered further for the selection process.
- 8. Posting shall be at any of the Offices/Stations/Projects/JVs/ Subsidiaries of NTPC. All posts are transferable at the sole discretion of the Management.

- after appointment his / her services are liable to be terminated without any notice. Canvassing in any form shall disqualify the candidate.

- Interested candidates should log on to our website careers.ntpc.co.in or visit the careers section at www.ntpc.co.in to apply. No other means/ mode of application shall be accepted. Candidates are required to possess a valid email ID. NTPC will not be responsible for bouncing back any email sent to the candidates.
- 2. Candidate belonging to General/EWS/OBC category is required to pay a non-refundable application fee of Rs. 500/-. The SC/ST/PwBD/XSM category & female candidates need not pay the application fee.
  - Payment in offline mode: State Bank of India has been authorized to collect the application fee, in a specially opened account (A/C No. 30987919993) at CAG branch, New Delhi (Code: 09996), on behalf of NTPC. Candidate has to approach the nearby SBI branch with a printout of the "pay-in-slip" which is available on the application portal. The pay-in-slip printed from the portal should only be used for depositing the fee for proper crediting of amount in the allocated account. On receipt of the money, the bank will issue a unique Journal Number and a Branch Code of the bank collecting the money. This journal number and the branch code are to be filled up by the candidate during an online application. NTPC will not be responsible, in case a candidate deposits the fee in the wrong account.
