Applications are invited for engagement to the post of Staff Consultant (Legal) on contract basis in BERC (hereinafter referred as 'Commission') under Bihar Electricity Regulatory Commission (Appointment of Consultants) Regulations, 2013 and its subsequent amendments.

## Terms & Conditions for Engagement of Staff Consultant (Legal)

### (1) Essential Educational Qualification:

1.1 Bachelor's degree in Law from a recognized University.

#### (2) <u>Desirable Qualification & Experience:</u>

- 2.1 Legal work experience in State/Central Govt./PSU/Statutory Body/ reputed non-government organisation.
- 2.2 Knowledge of Electricity Act, 2003 and rules & regulations made there under.
- 2.3 Good communication & drafting skills in legal matters.

#### (3) Age Limit:

3.1 Age should not be more than 60 years on the last date of submission of application.

#### (4) Period of Engagement:

The engagement will be initially for one year which may be extended on satisfactory performance as well as on requirement of the Commission for successive periods of 1 (one) year.
