**IMPORTANT NOTE:**

- Interested candidates fulfilling the eligibility criteria may report at Administrative Block AIIMS Bhopal for Document Verification on **29/09/2025 at 10:00AM** positively along with the duly filled in application in the prescribed format and with all documents in support of their eligibility (in original) and at least 01 set of self-attested photocopies & application fee in form of Demand Draft (if applicable).
- Candidates reporting for document verification after 11:30 AM may not be allowed unless in case of any genuine exigencies.

- c. Candidate should come for document verification with all relevant documents in original with self-attested photocopies for its verification.
- d. Candidates who fail to produce valid category certificate SC/ST etc during document verification or as and when required to produce the same, the candidature of such candidates is liable to be cancelled. All candidates are therefore advised to ensure that they possess required valid category certificate in advance.
- e. The above schedule is tentative and the Institute reserves the right to cancel or re-schedule the same depending upon the availability of Selection Panel or other Administrative reasons.
- f. The above vacancies are provisional and subject to variation. The Executive Director, AIIMS Bhopal reserves the right to vary the vacancy as per Institute's requirements. The reservation is as per the guidelines of MoHFW/Government of India.
- g. All prescribed qualifications shall be counted **as on date of Walk-in-interview i.e. 30/09/2025.**
- h. The engagement will be purely on contractual basis and under no circumstances are linked to regular appointments and cannot be regularized at any stage.
- i. The emoluments will be consolidated in nature @ 90,000 per month.
- j. The appointment is liable to be terminated by the Competent authority at any time within the Contractual period without assigning any reasons.
- k. The Executive Director, AIIMS Bhopal reserve the rights to cancel the advertisement at any point of time without prior notice or fill up less number of posts as advertised depending upon the Institutional requirements.

## **2. Application Process:**

Interested Indian Nationals/ persons registered as Overseas Citizen of India (OCI) cardholder under Section 7A of the Citizenship Act, 1955 and fulfilling all the eligibility criteria, are required to visit on the scheduled date with an application and original documents along with one set of self-attested photocopies of their proof of date of birth, eligibility qualification mark sheets, degrees, experience certificate and other relevant testimonials.

Interested Candidates fulfilling the eligibility criteria may come to AIIMS Bhopal for document verification on 29/09/2025 at 10:00AM positively (i.e. one day prior to the date of walk in Interview) along with the duly filled in application form in the prescribed format and supporting documents in original and at least 01 set of self-attested photocopies & application fee in form of Demand Draft (if applicable) etc.

Applicants are also advised to visit the Institute's website regularly for further updates.

## **3. Application Fees:**

The application fee for EWS/General/OBC category shall be Rs. 1,000/-.(Rs. One Thousand Only) by way of Demand Draft drawn in favour of “**Executive Director AIIMS Bhopal**”. Fee once remitted will not be refunded. No application fee is admissible for PwBD, SC/ST and women Candidates.

4. **No Objection Certificate:** Those who are working in Central/State Government/ /Semi Government/ Autonomous bodies shall be required to submit “**No Objection Certificate**” from their respective organization at the time of document verification/interview, failing which their candidature is liable to be rejected.
5. **Age Limit:**  
The age of candidates should be between **21-35 years** as on the date of Walk-In- Interview.
6. **Place of Interview:** The interview will be held at Administrative Block Kautilya Bhawan, All India Institute of Medical Sciences, Saket Nagar **BHOPAL-462020**
7. No TA/DA shall be paid appearing in the Interview.
8. After scrutiny & verification of the documents as per eligibility criteria, only eligible candidates shall be allowed to appear before the selection committee for interview. Candidates reporting for document verification must bring printed copy of the application form, No Objection Certificate from the current employer if applicable, and produce all relevant original documents in proof of details furnished in their application at the time of interview.

### **TERMS & CONDITIONS**

1. Canvassing of any kind will lead to disqualification.
2. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
3. Private practice of any type is prohibited.
4. He / She is expected to conform to the rules of conduct and discipline as applicable to the institute employees.
5. The selected candidates shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available/applicable to the Government Servants, appointed on regular basis.
6. The engagement of selected candidates can also be terminated at any time, on either side, by giving one month's notice or by paying one month's salary, without assigning any reason or failure to complete the period of three months to the satisfaction of competent authority. The appointee shall be on the whole-time appointment of the AIIMS Bhopal and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
7. Leave entitlement of the appointee shall be governed as per the existing rules of the Institute for Contractual Employees.
8. The selected candidates shall not be entitled to avail any allowances/facilities being extended to the regular/permanent faculty members of the AIIMS.
9. The candidate should not have been convicted by any Court of Law.

10. In case any information given or declaration by the candidate is found to be false or if the candidate has willfully suppressed any material information relevant to this engagement, the engagement is liable to be terminated immediately without notice and any other action taken as deemed fit by the Competent authority may be taken.
11. The decision of the competent authority regarding selection of candidates will be final and no representations will be entertained in this regard.
12. Applications incomplete in any aspect are liable to be summarily rejected.
13. The Competent Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice.
14. In case the number of candidates is more than 1:10 ratio a screening test may be conducted.
