In case no candidates are available for engagement in a particular reserved category in a particular super specialty, the available suitable candidate(s) in the respective super specialty will be engaged for a period of 44 days at the sole discretion of the ESIC.

ESIC Medical College & Hospital, Faridabad is providing Health Care Services to Insured Persons and Dependents belong to Grass root level of the society. To ensure availability of needful specialized medical services in an uninterrupted manner to them, in case no candidate is available for Super Specialists posts earmarked for EWS category, such posts will be filled by available eligible candidates on merit basis as part time super specialists (for a maximum tenure of one year) in the concerned discipline.

Important Instruction:

- 1. All the candidates are requested to appear for document verification along with duly filled in Application Form as attached within the scheduled time (09.00AM 10.00 AM) at Faculty Reading Hall, Academic Block, ESIC MCH Faridabad. No candidate will be entertained to attend document verification after 11.00 AM on all scheduled dates as mentioned above.
- 2. Only the Candidates, whose documents are verified and found eligible for the post of Full Time/Part Time Super Specialist will be allowed to attend walk-in interview.
- 3. Reservation of posts is applicable as per Government of India Guidelines.
- 4. The Dean, ESIC Medical College C Hospital reserves the right to vary these vacancies including increase or decrease or cancellation of filling up of any or all post without assigning any reason.
- 5. Change in date of interview, etc. if any, will be intimated on website only. Candidates are advised to check the website regularly for any updated information relating to the recruitment. Other terms and conditions as mentioned in **Annexure "A"**.
- 6. The engagement will be subject to outcome in case of recruitment related litigations if any.

ELIGIBILITY CRITERIA FOR THE POST OF FULL TIME / PART TIME SUPER SPECIALIST

Upper age limits will be 69 years as on the date of interview (relaxable as per discretion of the competent authority if candidate below the age of 69 years does not appear).

- i) MBBS and MD/MS/DNB Degree from MCI/NMC recognized Medical College/ Institution.
- ii) DM/MCH in respective Super Specialty from MCI/NMC recognized Medical College/DNB in concerned super specialty or equivalent.
- iii) Should have registered with MCI/NMC or State Medical Council.
- iv) Five years' experience in the concerned specialty after obtaining the First Post Graduate degree.
- v) The Academic Qualification in the department of Reproductive Medicine C Surgery is detailed as below:

Academic Qualifications	Teaching and Research Experience
DM/MCh/DNB in the concerned subject.	Five years' experience in the concerned specialty after obtaining the First Post Graduate degree
OR <u>During Transition Period</u> MD/MS/ DNB in the concerned Broad Specialty subject.	Special Training for three years in the respective new super specialty subject in a teaching institution/Centre of Excellence with dedicated service in that specialty.

Note: -

- Candidates with at least five years post super specialty qualification experience will be considered for engagement as Consultant (Senior Level).
- Qualifications with regard to experience are relaxable at the discretion of the Appointing Authority on recommendation of the Selection Committee in case of candidates otherwise well qualified.

Emoluments for the Post of Full Time / Part Time Super Specialist

For Full Time Super Specialists: -

- Super Specialist (Entry Level) Rs. 2,00,000/- (Consolidated remuneration) per month.
 No other allowances in any form shall be admissible.
- 2. Consultant (Senior Level) Rs. 2,40,000/- (Consolidated remuneration) per month. No other allowances in any form shall be admissible.

For Part Time Super Specialists: - (Duty Hours: 04 hours per day s 04 days in a week)

- 1. Super Specialist (Entry Level) Rs. 1,00,000/- (Consolidated remuneration) per month for 04 hours per day C 04 days in a week.
- 2. Consultant (Senior Level) Rs. 1,50,000/- (Consolidated remuneration) per month for 04 hours per day C 04 days in a week.

In addition, **Rs. 20, 000**/- per month for visiting charge in case of emergency visit and **Rs. 1200**/- for every additional hour of **Super Specialist (Entry Level)** and **Rs. 1500**/- for every additional hour of **Consultant (Senior Level)**. The additional hour of work will be decided by the MS / Dean. No other allowances in any form shall be admissible.

Terms s Conditions for Full/Part Time Super Specialist

- a) In case of Full time Super Specialist, the engagement will be for a minimum period of one year or till regular incumbent joins or till faculty on contract basis is recruited through walk-in interview whichever is earlier. The contract would be extendable yearly based on satisfactory performance.
- b) In case of Part time Super Specialist, the engagement will be for a period of **one year** or till regular incumbent joins or till faculty on contract basis is recruited through walk-in interview whichever is earlier.
- c) In respect of candidates engaged under full time basis, private practice of any kind will not be allowed.
- d) In case of selection, the engagement in respect of Full time/Part time Super Specialist is up to the age of 70 years or the contracted period whichever is earlier.
- e) The Super Specialist shall be available on call 24x7.
- f) The Super Specialist shall be responsible for all cases undergoing treatment under his supervision in that specialty discipline.
- g) The Selected Specialist must have a professional indemnity policy which should cover the period of contractual engagement. The policy is meant to cover professional liability falling on them as a result of error and omissions committed by them while rendering professional services. The minimum sum assured per annum should be Rs.30 lakh for Anesthesiologists, Cardiac Surgeon, Neuro Surgeons, Plastic Surgeons etc. (2) Rs. 20 lakhs for General Surgeons, Gynecologist, Obstetrician etc. (3) for Physicians Dentists, Radiologists, Pathologists etc. it should be at least of Rs. 10 lakhs. A copy of the Insurance s Premium and receipt must be submitted within 7 days from the date of engagement.
- h) Selected candidates will have no claim for regularization of services in the Hospital/Medical Institution.
- i) The Full time Super Specialist is entitled for 2.5 paid Leaves on per completed month of service.
- j) The Part time Super Specialist will not be entitled for any kind of leave benefits.
- k) The appointment is subject to Medical Fitness.
- l) No TA/DA will be admissible for attending the interview/joining the post.

- m) The selected Full Time/Part Time Super Specialist will be required to submit acceptance/consent letter in writing before appearing for medical examination.
- n) The appointing authority reserves the right to terminate the appointee anytime even before the tenure without assigning any reason by giving one month notice. Similarly, the engaged person will have to give one-month prior notice before resigning or will have to pay an amount equivalent to one month's remuneration in lieu of the notice period.
- o) Candidates applying in OBC/SC/ST/EWS/PWD Category must possess the certificate issued by competent authority, valid for admission/ job in Central Govt. Institutions issued before the date of interview, failing which he/she can be treated as UR Candidate.
- p) The doctors at any time found guilty of any gross misconduct or negligence of his/her duties shall be terminated without any notice or payment in lieu of the notice period.
- q) Selected candidates will join duty immediately or the date indicated in the offer of appointment/engagement likely to be issued, failing which the offer letter will be treated as cancelled.
- r) Full time/Part time Super Specialist has to wear his/her own white coat with name badge during the duty hours.
- s) He/ She will be required to mark attendance manually as well as AEBAS (Aadhar Enabled Bio Metric Attendance System).
- t) Candidates are requested to bring their original certificate in evidence of age of proof (date of birth), educational qualification, medical council registration of the State/MCI/NMC, experience certificate along with one set of self attested photocopies with 2 recent passport size photographs for appearing in the walk-in interview without fail.
- u) The selected candidates shall have to submit an agreement incorporating the terms and conditions of appointment on a Rs. 100/- Stamp Paper in the format provided by the Institution.

(ii) Mode of Payment: -

A Demand Draft for Rs.500/- (as applicable) in favor of **'ESI Fund Account No.1'** drawn on any scheduled bank payable at Faridabad has to be submitted along with application form at the time of document verification cum walk-in Interview.

Note:

- (i) Fee once paid will not be refunded under any circumstances.
- (ii) Only Demand Draft drawn on any Scheduled Bank will be accepted. Application fee Paid by any other mode will not be accepted.

The following testimonials should be submitted at the time of walk-in-interview:

- (i) Two copy of recent self-attested passport size photograph.
- (ii) Self-attested copies of certificates and testimonials in support of proof of age (Date of Birth), Educational Qualification, Experience and Research Papers, Publications etc.
- (iii) Original certificates and testimonials in support of proof of age (Date of Birth), Educational Qualification, Experience and Research Papers, Publications etc., should be submitted at the time of interview.
- (iv) Candidates seeking reservation benefits under SC/ST/OBC/EWS/PWD category must ensure that they are entitled to such reservation as per eligibility prescribed in the notice and as per the instructions issued by Govt. of India. They should also produce original certificates in the prescribed format of Govt. of India in support of their claim.
- (v) Persons working in Central Government/State Government/Central Autonomous bodies/ State Autonomous bodies/Central PSUs/State PSUs/have to produce no objection certificate from their employer at the time of document verification.

Selection Procedure:

- (i) The aspiring applicants satisfying the eligibility criteria in all respects can appear for the walkin interview as per the days mentioned above.
- (ii) The applications of the candidates submitted on the day of walk-in interview along with the requisite fee will be scrutinized by the scrutiny committee of the Institute and only the eligible Candidates will be allowed to appear for walk in interview before the selection committee. In case, the numbers of applicants are large, the selection committee of the Institute may devise criteria for short-listing of the candidates which may include holding of a Screening Test.
- (iii) The selection will be made on the basis of performance of the candidate in interview before the Selection Board.
- (iv) Result will be published on the website (<u>www.esic.gov.in/recruitments</u>).
- (v) Selected candidates will have to join immediately after receipt of the offer of engagement.

General Instructions:

- (i) Mere submission of application does not confer any right to the candidate to be eligible for interview unless they report on the scheduled date and time.
- (ii) Application should be submitted in the prescribed format only (Annexure 'B'). The applications submitted in any other format OR incomplete applications will be summarily rejected.
- (iii) The candidates may ascertain their eligibility and report for interview on the scheduled date and time for interview. Candidates reporting after scheduled time will not be allowed to attend the interview process.
- (iv) ESIC reserves the right to cancel the recruitment process at any stage at its discretion and such decision will be binding on all concerned.
- (v) Wrong declarations/submission of false information or any other action contrary to law shall lead to cancellation of the candidature at any stage in addition to suitable legal action.
- (vi) Opportunity for appearing in the interview given to the candidates is purely on provisional. Joining of the candidates will be subject to detailed scrutiny of eligibility conditions/production of prescribed certificates in case of reservation.
