# Terms and Conditions for recruitment of contractual Senior Resident at North DMC Medical College, Delhi

- 1. Number of posts for all category may increase or decrease including complete withdrawal.
- 2. Reservation of posts will be as per Govt. of India Rules.
- 3. The appointment and services will be governed under-Residency of Govt. of India, Ministry of Health and Family Welfare and amendment thereafter/relaxation as detailed in eligibility criteria and in accordance of Office Order No. 86/DHA/2024 dated 27.06.2024.
- 4. The candidates will have to take the printout of the application form, fill up and bring the filled form along with Bank Draft/Pay order of Rs. 1000/- (Rupees One Thousand Only) for General/EWS/OBC categories and Rs. 500/- (Rupees Five Hundred Only) for (SC/ST) category, in favour of *Commissioner, Municipal Corporation of Delhi,* payable at Delhi. No fees for PWD beneficiaries, subject to the submission of valid certificate in support of claim.
- 5. The candidate already in service (Govt. /Semi Govt. /Corporation or Autonomous Body) should apply through proper channel. The candidate who is in service will have to bring 'No Objection Certificate' from his/her Head of Institution/Employer at the time of interview otherwise, he/she will not be allowed to appear for interview.
- 6. Those seeking benefits of reservation for EWS/SC/ST/OBC/PwBD must submit caste/respective certificate in his/her name issued by the Component Authority (In case of OBC the valid certificate should be issued from NCT of Delhi). All prospective candidates are advised to check their eligibility regarding admissibility of benefit of reservation accordingly.
  - a) The OBC candidates applying against this notification must produce OBC (Non-Creamy Layer) certificate issued in last one year.
