EMPLOYMENT NOTICE

In terms of provisions laid down under section 42(5) of Electricity Act 2003 and Regulation 2 of the Bihar Electricity Regulatory Commission (Consumer Grievance Redressal Forum, Electricity Ombudsman and Consumer Advocacy) Regulations, 2017 as amended from time to time applications are invited in the prescribed format for appointment of Third Member for the following "Consumer Grievance Redressal Forums (C.G.R.F.)" at:

- (1) ARA (2) NALANDA (3) GAYA (4) SASARAM (5) AURANGABAD (6) JAMUI
- (7) BHAGALPUR (8) MUNGER (9) PESU (West), PATNA (10) PESU (East), PATNA
- (11) MOTIHARI (12) CHAPRA (SARAN) (13) DARBHANGA (14) SAMASTIPUR
- (15) SAHARSA (16) KISHANGANJ (17) BEGUSARAI (18) PURNEA (19) MUZAFFARPUR.

Eligibility criteria and other terms and conditions are as follows:

- 1. Functions, Powers and responsibilities of the Forum and its Member are specified in "Bihar Electricity Regulatory Commission (Consumer Grievance Redressal Forum, Electricity Ombudsman and Consumer Advocacy) Regulations, 2017" and subsequent amendments which can be seen on the website of the Commission www.berc.co.in.
- 2. The Third Member shall be an Independent Member. The person shall be a representative of a registered society/NGO/ consumer organization having one of its main objectives as consumer protection with at least 5 years of consumer-related matters or a person of stature and repute having at least five years exposure and experience of consumer affair and the minimum qualification shall be graduate in any discipline from a recognized university. Provided that, a person applying for the post of Independent Member of the Forum shall not have been in the employment in any capacity under, or agency of, the Electricity Distribution Licensee for a minimum period of three (3) years prior to being appointed Independent Member of the Forum.
- 3. Third Member of the forum shall hold office for a fixed term of three years in that particular forum from the date of appointment or till he/she attains the age of 60 years whichever is earlier. This tenure of three years may be relaxed by the Commission. The tenure of Third Member may be extended further after three years, if performance is satisfactory, for a period of two years or till the age of 60 years, whichever is earlier.
- 4. The minimum age limit for applicant for the post of Third Member shall be 35 years as on the last date of receipt of application i.e. 25.8.2025.
- 5. The candidate should be a person of experience, ability, integrity and standing having adequate knowledge in his respective fields.
- 6. Third Member shall be whole time Member of the Forum and shall not undertake any other part time or honorary work.

- 7. No person will be appointed and/ or be entitled to continue as a Member if he/she stands disqualified on account of his/her:
 - a) Having been adjudged an insolvent;
 - b) Having been convicted of an offence which, in the opinion of the Commission, involves moral turpitude;
 - c) Having become physically or mentally incapable of acting as such a member;
 - d) Having acquired such financial or other interest as is likely to affect prejudicially his/her functions as a member;
 - e) Having so abused his/her position as to render his/her continuance in office prejudicial to public interest; or
 - f) Having been guilty of proved misbehavior.
 - g) Having become Member of any Political Party.
- 8. The Third Member may relinquish his/her office by giving prior notice in writing not less than three months to the appointing authority. Similarly, if the Third Member of the Forum is removed, appointing authority shall give prior notice in writing not less than three months to the Third Member of the Forum.
- 9. The sitting fees, honorarium and/ or other allowances (Collectively "Remunerations") payable to the Third Member by the Distribution Licensee concerned shall be a consolidated sum of Rs. 45,000/- (Rs. Forty-five thousand) per month.
- 10. Candidates who fulfill the above criteria and is desirous of appointment on the said post, must submit their application addressed to the Secretary, Bihar Electricity Regulatory Commission, Vidyut Bhawan-II, Nehru Path (Bailey Road), Patna-800021 by registered post or speed post so as to reach by 5:30 PM on 25.8.2025.
- 11. Applications received after the due date i.e. **25.8.2025 or** incomplete applications shall not be entertained.
