1. The aspiring applicants satisfying the eligibility criteria in all respects can appear for the walk-in interview as per the days mentioned above.
2. The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must be fulfilling eligibility criteria in all respects as on the date of interview.
3. The candidates can appear for the walk-in interview in the discipline of Emergency Medicine and Physical Medicine & Rehabilitation in addition to their own specialty.
4. **Academic Qualification during the Transition Period as per eligibility criteria by NMC-TEQ 2025 read with MSR 2023:**

For Emergency Medicine - Candidates from the specialties of General Medicine, Anaesthesia, Respiratory Medicine, General Surgery and Orthopaedics can appear for the walk-in interview in addition to their own specialty.

Only when there is no person with benchmark disability available for the post, the employer shall fill up the vacancy by appointment of a person, other than a person with benchmark disability, vide office memorandum dated 15.01.2018.

The person who suffers from not less than 40% of disability will only be eligible for the benefit of reservation and other relaxations under PWD category as permissible under the rule. Important Instructions: -

Senior Resident: Any person undergoing residency in a relevant department of a recognised medical institution after obtaining the following qualification, namely:

(a) Postgraduate degree in **Doctor of Medicine** or **Master of Surgery** or **Diplomate of National Board**; or

(b) Postgraduate medical degree in Master of Science with Doctor of Philosophy in the medical subjects of Anatomy or Biochemistry or Physiology or Pharmacology or Microbiology, shall be eligible for appointment as a Senior Resident.

Age: The upper age-limit for appointment as a Senior Resident in broad specialties shall be **forty-five years**: Provided that for the subjects of Anatomy, Biochemistry, Physiology, Pharmacology, Microbiology, Pathology, Forensic Medicine and Community Medicine, the upper age-limit shall be **fifty years**.

- 1) (a) The candidates from the specialties of General Medicine, Anaesthesia, Respiratory Medicine, General Surgery and Orthopaedics can appear for the walk-in interview in the discipline of Emergency Medicine.

(b) The candidates from the specialties of Medicine with Diploma in PMR, General Surgery and Orthopaedics can appear for the walk-in interview in the discipline of Physical Medicine & Rehabilitation in addition to their own specialty and the relaxation in Academic Qualification during the Transition period is extended by five years from 14.02.2022.

General Terms and Conditions for Senior Resident

Terms of Contract:

1. **Senior Resident** – The tenure of 3 years for Senior Residents is subject to satisfactory performance evaluation on annual basis. No extension beyond 3 years of the tenure.
2. **Candidates who have worked already as a Senior Resident under 3 years Central Residency Scheme for 3 years are not eligible for applying for the post of Senior Resident. Senior Resident who are already working in any Govt. institution/ Hospital shall apply through proper channel. The total period however, should not exceed the maximum period of 3 Years.**
3. **Remuneration:** - Initial Pay in **Level -11** with basic pay of **Rs. 67,700/-** plus other allowances as applicable under 7th CPC. Private practice of any kind will not be allowed.

Total Gross Emoluments drawn by a Senior Resident (3 years) for the month of August 2025 is Rs. 1,57,392/- (approximately) and this remuneration will be revised whenever there is revision of rates of DA as per ESIC Hqrs. Office which is line with the Central Government Employees.

4. **Senior Resident (3 years tenure) will be eligible for kinds of leave as admissible to temporary government employees in accordance with the provisions of CCS (Leave) Rules 1972.**
5. Rules for Reservation will be implemented as per Govt. of India instructions.
6. The engagement shall not confer any right or preference for regular appointment.
7. No claim for any service benefits like PF, Pension, Gratuity, Medical allowances, Medical benefits, Seniority, Promotion etc. will be admissible.
8. Candidate must be registered with State Medical Council/NMC as applicable, before joining the post.
9. Candidate in the Government Service should submit “No Objection Certificate from the employer at the time of Interview.
10. The candidates who are already employed must produce relieving order from the previous employer at the time of joining / NOC for taking up engagement with ESIC.

11. No TA/DA will be admissible for interview or joining.
12. ESI Corporation may increase or decrease or cancel filling up of any or all posts without assigning any reason at the discretion of the Appointing Authority.
13. Candidates applying in **OBC/SC/ST/EWS/PWD** Category must possess the certificate issued by competent authority, valid for admission/ job in Central Govt. Institutions issued before the date of interview, failing which **he/she shall not be allowed to appear in interview for the reserved category.** However, he/she can be treated as UR Candidate.
14. The candidates claiming reservation on grounds of belonging to **OBC [non-creamy layer]** should submit the community certificate in Annexure "A" prescribed vide Govt. of India, Department of Personnel and Training O.M No. 36036/2/2013-Estt (Res) dated 30.05.2014 failing which the benefits of reservation will not be given and their application shall be rejected and no request /correspondence will be entertained. **Certificate issued in other formats will not be accepted and the candidature will be treated as "General Category" for all purposes.**
15. The candidates appointed under PWD quota will be adjusted against the vacancy of respective categories of SC/ST/OBC and UR quota. The disability certificate should be issued by a duly constituted and authorized Medical Board of the State or Central Government Hospitals/Institutions.
16. The DEAN has the discretion to increase/decrease the number of vacancies depending on actual requirement or to cancel this recruitment or to withdraw offer of appointment.
17. The Senior Resident so selected will be required to submit acceptance/consent letter in writing before appearing for medical examination.
18. The doctors at any time found guilty of any gross misconduct or negligence of his/her duties shall be terminated without any notice or payment in lieu of the notice period.
19. The absence from work for a period of fifteen days without proper permission of the competent authority will amount to voluntary abandonment of engagement and automatic termination. The Medical Officers are required to mark attendance manually as well as on Aadhar Enabled Bio-metric Attendance System (AEBAS) daily during scheduled working days.
20. They will also be required to attend emergency, floor duty and other clinical duty as assigned by the Competent Authority.
21. They will also be required to perform duties in other departments as assigned by the competent authority.
22. Selected candidates will have to join duty on or before the date indicated in the offer of appointment/engagement likely to be issued.
23. The Senior Resident so engaged will be required to enter into a contractual agreement for the purpose on a **stamp paper of Rs.100/-**.
24. **Security Deposit:** The Selected Senior Resident candidates have to deposit security amount of **Rs. 30,000/- (Rupees Thirty Thousand)** in favour of ESI Fund A/C No. 1 payable at State Bank of India, Ashok Nagar, Chennai-78 and submit the demand draft at the time of joining.
