3. ELIGIBILITY CRITERIA AS ON 01/09/2025:

The candidate should have the relevant experience as mentioned below and shall be conversant with functioning in a computerized environment. Hands on knowledge of various computer applications, relating to the job would be desirable. The officer from Government organizations should be free from D&AR and Vigilance angle.

I) <u>Essential Experience</u>

- a) Must have 15 years of professional experience in the Rail Sector; and
- b) Out of the total experience requirement as provided in 3.(I).(a) above, he/ she should have a minimum of 5 years of operations and/or maintenance experience of Metro System.
- c) Out of the total experience requirement as provided in 3.(I).(a) above, he/ she should have a minimum of 3 years of operations and/or maintenance experience as Head, or, Deputy Head O&M, or, known by whatever name with equivalent capacity of a Metro System.

II) Pay Scale/ Pay Eligibility Criteria

a) For candidates working in / having worked in CDA/ IDA pay scales

Officials working in/ retired from the posts in analogous grade in the CDA pay scale in Level-15 (182200-224100) or, IDA pay Scale of Rs. 150000- 300000/-; in Government organization or, Rail/ Metro Transport System, including services put in on deputation, in the above pay scale, and having relevant experience as mentioned in para 3 (I) above, with a total of twenty-five years' service at the Gazetted/ Executive level in Govt. organization, or, Rail /Metro Transport System.

b) For candidates working in/ having worked in the private sector on annual CTC basis

Officials working in/ having worked with Rail/ Metro Transport System with a total of 25 (Twenty-Five) years' service at Executive level with having relevant experience as mentioned in para 3 (I) above and having/ had annual CTC of Rs. 40 Lakhs and above, shall be eligible for the above said position.

4. JOB DESCRIPTION:

The incumbent for the key position (CEO) shall be responsible for the operation and Maintenance works of Chennai Metro Rail Corporation Ltd. (CMRL), Phase-II. The detailed roles & responsibilities shall be as under:

- Shall be O&M Contractor Representative for the O&M Contract.
- Shall be authorized by the O&M Contractor to take all decisions and actions on behalf of the O&M Contractor for the performance of the O&M Services.
- Instructions given to CEO shall have the same force as the same had been given to the O&M Contractor itself.
- O&M Contractor may elect to augment the CEO with additional dedicated personnel. But the CEO shall have the primary responsibility for the O&M Contractor's performance.
- The CEO shall be full time devoted exclusively to perform the O&M Services

5. TERMS OF APPOINTMENT

- a) Normal age of retirement in DMRC is 60 years.
- b) Normal tenure of Deputation is five (05) years, which may be extended further to seven (07) years, in special cases, or, till the date of superannuation, whichever is earlier.
- c) The initial engagement on Post Retirement Contractual Engagement basis shall be for a period of one year. The term of contract may be extended further, subject to the requirement of the Corporation, on the basis of satisfactory performance.

6. JOB LOCATION/ PLACE OF POSTING

The incumbent for the post shall initially be posted at Chennai. However, the selected candidates shall be liable to be posted/ transferred to any of the offices/ Project sites under the control of the Corporation in India, or, abroad.

7. PAY AND EMOLUMENTS:

- i) For Candidate selected on Direct Recruitment Basis- The pay and emoluments shall be as per the pay scales under the IDA (Industrial DA), as applicable from time to time and other benefits which include Perks, Lease/HRA, Medical benefits, EPF, Gratuity and Insurance, etc., as per the extant rules of the Corporation.
- **ii)** For Candidate selected on Deputation Basis- The selected candidate shall continue to draw parent department pay plus deputation allowance, as applicable, under the relevant rules.
- iii) For Candidate selected on Post Retirement Contractual Engagement Basis- The selected candidate shall be eligible for a consolidated emolument of Rs. 1,82,500/- plus applicable HRA/ Lease facility and others benefits, as per the company policy.

The emoluments are in terms of the extant rules of DMRC. The remuneration shall be based on their last substantive grade, subject to a maximum amount, as indicated above.

8. SCREENING PROCESS:

The screening methodology for **Direct Recruitment and Post-Retirement Contractual Engagement basis** shall comprise of **Personal Interview** and **Medical fitness examination**.

The screening methodology for **Deputation basis** shall comprise of **Personal Interview**.

(The Medical Examination shall be in the Executive / Technical category. The details of Medical Examination are available in the DMRC website).

The selection process would judge different facets of knowledge, skills, comprehension, aptitude and physical fitness. Candidates would have to qualify the **Screening Process** and **Medical examination**, before being adjudged as suitable, for selection. Candidates, who fail in the prescribed medical test, **shall not** be given any alternative employment and decision of the Corporation shall be final on the issue.

9. CHARACTER & ANTECEDENTS:

The success in the screening process shall not confer any right to appointment unless the Corporation is satisfied, after such an enquiry, as may be considered necessary, that the candidate having regard to his / her character & antecedents, is suitable in all respect, for appointment to the service.

10. SURETY BOND:

The candidate selected for the post shall have to execute a Surety Bond of **Rs. 4,00,000/-**, or, as per applicable amount, to serve this Corporation for a minimum period of three years (exclusive of the period in which one remains on LWP or EOL), or, till retirement (whichever is earlier). Three months' prior notice, shall be required before seeking resignation from the Corporation.

11. PROBATION:

The selected candidate on appointment shall be on probation for a period of one year (including the period of training), or, till retirement, whichever is earlier.

12. SCHEDULE OF SELECTION:

- i) Last date of receipt of duly filled in application (along with relevant documents) through Speed post OR e-mail shall be **24/09/2025**. Incomplete applications or applications received after the due date shall be summarily rejected. DMRC shall not be responsible for loss / delay in post.
