Terms & Conditions in detail

- (1) The posts under Commission are non transferable and posting will be only at Patna.
- (2) The Commission shall have full discretion to make appointment against the advertised post and Commission's decision in this regard shall be final.
- (3) Terms and Conditions for contract basis shall be as per provision in Bihar Electricity Regulatory Commission (Recruitment and Terms and Conditions of Service of Officers and employees) Regulations, 2014.

(4) Age

- (i) Cut-off date for calculation of age will be 17.10.2025
- (ii) Minimum age for appointment will be as per State Govt. norms.
- (iii) The maximum age limit for appointment on contract basis for non-retired persons shall be 55 years.
- (iv) The maximum age limit for appointment on contract basis for retired persons shall be 62 years.

(5) Appointment on Contract

- (i) The eligibility criteria for post to be filled up on contract basis shall be as prescribed in Schedule-II of the Bihar Electricity Regulatory Commission (Recruitment and Terms and Conditions of Service of Officers and employees) Regulations, 2014 subject to guidelines issued by the State Govt. In deserving cases the Commission shall have the discretion to relax eligibility conditions (except educational gualification) for reasons to be recorded.
- (ii) Persons appointed on contract basis shall enter into an agreement which shall govern their broad service conditions of appointment in a format to be prescribed by the Commission.
- (iii) The appointment on contract basis under these regulations in case of retired persons shall be initially for 2 (two) years which may be extended as per requirement for successive periods of 1 (one) year each upto maximum age limit of 65 years after review of his performance. The appointment on contract basis, in case of non retired candidate, shall be initially for one year which may be extended as per requirement for further period if his work after review is found satisfactory.
- (iv) The services of an employee appointed on contract basis may be terminated any time for the reasons to be recorded in writing, giving one month's notice or payment of one month salary in lieu thereof.
- (v) In case of persons retired from Government/PSU etc. where pension scheme exists, the remuneration shall be fixed on the basis of pay last drawn minus pension in light of the circulars issued by Govt. of Bihar time to time.
- (vi) In case of persons who retired from an organisation where pension scheme does not exist, remuneration will be determined on the basis of last gross pay drawn or the gross pay prescribed for the post whichever is less. The pay fixed shall be consolidated pay and no increment will be admissible.

(vii) In case of non retired persons remuneration shall be fixed on the basis of basic pay plus other allowances admissible for the posts. But increment in pay and allowances will not be admissible.

(6) Selection Procedure

- (i) Subject to the general guidelines issued by the State Government, appointment shall be made for filling up the vacancy against the sanctioned posts in the Commission as per educational gualification and experience mentioned above.
- (ii) All applications shall be scrutinized and shortlisted by a Committee to be constituted by the Commission for this purpose.
- (iii) Eligible shortlisted candidates will have to appear before the Commission or the Selection Committee appointed by it for interaction.

(7) <u>Instruction of filing application</u>

- (i) The candidate shall apply for the post only in the prescribed format, other-wise the application will be rejected.
- (ii) No column of application form should be left blank. Name of the Post applied for must be mentioned on the envelope. Incomplete application or applications received after due date i.e. on 17.10.2025 after 5:00 PM will be summarily rejected.
