APPRENTICE TRAINING NOTIFICATION

Hubli Electricity Supply Company Limited is inviting online applications from eligible B.E Graduate & Diploma holders in Electrical & Electronics Engineering for one year's apprenticeship training from November-2025 under the Apprenticeship Act 1961.

1. Requirement:

2. Requisite Qualification:

- (i) Graduates : Should have passed with a B.E./ B.Tech degree in Electrical & Electronics from a recognized University /Institution (recognized by AICTE or State Govt. / Central Govt.) in relevant branch.
- (ii) Diploma holders : Should have 3 years' Diploma from a polytechnic college/ institution in Electrical & Electronics recognized by the State Govt./ Central Govt. in relevant branch

The candidates who have already undergone or are currently undergoing apprenticeship training under Apprenticeship Act 1961, and /or already having one-year's work experience are not eligible.

3. Age limit: Age limit will be followed as per Apprenticeship Rules.

4. Reservation:

Guidelines under Apprentices Act on Reservation for SC/ST/OBC/PWD will be followed. Those who are claiming reservation under SC/ST/OBC/PWD shall provide certificate as per Government standard format, failing which their claim for reservation will be considered under 'General' category only. If BC candidates claiming OBC category, they should bring OBC certificate as per the Govt. prescribed (OBC) format from the certificate issuing authority.

5. MINIMUM PHYSICAL FITNESS STANDARDS:

As prescribed in Clause 4 of the Apprenticeship Rule 1992, and amendments thereof if any.

6. DURATION OF TRAINING:

The duration of apprenticeship training will be for a period of one year.

7. SELECTION PROCEDURE:

Please note that, the Board of Apprenticeship Training (Southern Region) is entrusted with the task of short-listing the candidates from online application data. Short listing process will be done based on the marks secured in the qualifying examinations. The list of short listed candidates will be hosted in our HESCOM website www.hescom.karnataka.gov.in and NATs Portal (<https://nats.education.gov.in>). The candidates will also be intimated through their registered Email IDs.

Short listed candidates will have to appear in person for verification of documents at the "Office of the Executive Engineer (Ele.), ITC, HESCOM, Karwar Road, Vidyut Nagar, Hubballi."

10. GENERAL INSTRUCTIONS:


- The candidates should have knowledge of reading and writing in Kannada language.

- It shall not be obligatory on the part of the HESCOM to offer any employment to the apprentice on completion of period of apprenticeship training nor shall it be obligatory on the part of the apprentice to accept an employment under the employer as per Apprenticeship Act 1961 specified in Schedule VI, Rule 6.
- Incomplete / Erroneous online applications received before or any application received after due date will be rejected. No further correspondence or enquiries will be entertained in this regard from candidates.
- Board of Apprenticeship Training, (Southern Region) has not entrusted/authorized any other organization to coordinate (or) liaison the selection process. Candidates are instructed to beware of touts; this office shall not be held responsible for such unwanted incidents.
- Canvassing/Pressuring through any source will disqualify the candidature.
- The decision of HESCOM in matters relating to eligibility of the candidates will be final.
- The candidates shall furnish valid e-mail ID and mobile number / contact number for future communication in the online application.

- The company reserves the right to cancel the Apprenticeship Training Notification during any stage and without prejudice to issue fresh notification, if necessary.


