- Age Limit: Candidates must be between 50 and 65 years of age as on the last date of receipt of applications.
- 3. Before applying for Consultant (IT), the candidate should ensure that he/she satisfies the prescribed eligibility conditions therefor.
- 4. If, at any stage, it is found that the candidate does not fulfill any of the eligibility conditions or information furnished by him/her is found false or he/she has suppressed any material information, his/her candidature for Consultant (IT) will stand cancelled without any notice or further reference.

- 5. The Registry of the Tribunal reserves the right to enlarge or modify the scope of duties to be performed by the selected candidate for being engaged as Consultant (IT), and cancel the notification without assigning any reasons thereof.
- 6. The Consultant shall be eligible for 1.5 days' leave for each completed month of his/her term as Consultant on pro rata basis. The unavailed leave will not be carried over to the next term.
- 7. Apart from the monthly consolidated remuneration, as mentioned above, subject to TDS, the Consultant shall not be entitled to any kind of allowances, such as Dearness Allowance, Conveyance Allowance, House Rent Allowance or any other facilities, like Residential Accommodation, Personal Staff, Transport, and Medical Reimbursement etc.

The engagement of Consultant (IT) will be purely contractual in nature for a period of one year, which can be extended, if the Tribunal so requires and the work and conduct of the candidate is found to be satisfactory.
