CIRCULAR

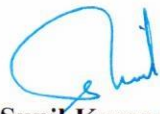
Applications in the prescribed format are invited from the Indian Citizens, who fulfill the following qualifications, experience and other eligibility conditions for being engaged as Consultant (IT) purely on contract basis for a period of one year at a monthly consolidated remuneration of Rs 1,00,000/- (Rupees one lakh only) in the Armed Forces Tribunal, Principal Bench, New Delhi:

Qualifications	Experience
Master of Computer Application/ Bachelor of Engineering/ Bachelor of Technology from recognized University or equivalent.	Minimum five years' experience in the working in client-server and web-based technologies, LAN/WAN Network Administration, system integration and support services. OR Minimum five years' experience in IT/Software Development/IT System Projects/Website Management/Mobile Application in Website/Mobile Application Development for IT Projects, Database Administration or related fields in reputed organisaion. Desirable Experience. 1. Experience with open-source platforms or cloud based systems. 2. Proficiency in programming language (e.g. Java, Python, PHP, etc.) 3. Working knowledge of cyber security protocols and data protection policies 4. Ability to manage end-to end IT project, lifecycle. Note: Preference will be given to candidates who have worked on IT projects in a judicial or quasi-judicial/ Court /Tribunal environment and possess a comprehensive understanding of the digital requirements and sensitivities of such institutions

2. Age Limit: Candidates must be between 50 and 65 years of age as on the last date of receipt of applications.
3. Before applying for Consultant (IT), the candidate should ensure that he/she satisfies the prescribed eligibility conditions therefor.
4. If, at any stage, it is found that the candidate does not fulfill any of the eligibility conditions or information furnished by him/her is found false or he/she has suppressed any material information, his/her candidature for Consultant (IT) will stand cancelled without any notice or further reference.

5. The Registry of the Tribunal reserves the right to enlarge or modify the scope of duties to be performed by the selected candidate for being engaged as Consultant (IT), and cancel the notification without assigning any reasons thereof.
6. The Consultant shall be eligible for 1.5 days' leave for each completed month of his/her term as Consultant on pro rata basis. The unavailed leave will not be carried over to the next term.
7. Apart from the monthly consolidated remuneration, as mentioned above, subject to TDS, the Consultant shall not be entitled to any kind of allowances, such as Dearness Allowance, Conveyance Allowance, House Rent Allowance or any other facilities, like Residential Accommodation, Personal Staff, Transport, and Medical Reimbursement etc.
8. The engagement of Consultant (IT) will be purely contractual in nature for a period of one year, which can be extended, if the Tribunal so requires and the work and conduct of the candidate is found to be satisfactory. However, the Tribunal reserves the right to terminate the engagement as Consultant (IT) before the expiry of the term of engagement without assigning any reasons, whatsoever.
9. The Consultant shall follow the normal working hours as prescribed from 09.30 a.m. to 05.30 p.m. However, in case of exigencies, he/she may be required to sit late to complete the time bound work.
10. The Consultant to be engaged on full time basis shall not be permitted to take up any other assignment during the period of the consultancy in the Armed Forces Tribunal, Principal Bench, New Delhi.
11. The engagement of the candidate selected for Consultant (IT) does not confer any right on him/her to claim regularization or continuance of his term of contract beyond one year.
12. The application in the prescribed format of the eligible candidate must reach the Principal Registrar, Armed Forces Tribunal, Principal Bench, West Block-VIII, R.K. Puram, New Delhi 110066 latest by **19th December, 2025** along with photo copies of the documents in support of his/her qualifications and experience, as prescribed above.
13. The applications received without supporting documents, unsigned and incomplete, in any manner, will be summarily rejected.
14. No TA/DA will be payable to the candidates to appear for the interview.
