1. The engagement for SRF will be initially **upto March, 2026** or till the date of termination of project, whichever is earlier. The appointment is purely temporary and co-terminus with the duration of the project subject to satisfactory performance.

3. The selected candidates will be initially posted at Research Centre, Koraput. However, he /she can be posted anywhere preferably within Odisha State as per the requirement of the Project without any extra payment except emoluments. Project sites located at Koraput & Nabarangpur.
4. The positions are purely time bound, temporary on co-terminus basis with the Project and do not entitle the appointment to any claim implicit or explicit on any ICAR post.
5. The essential qualification given in the advertisement against each position is minimum. Candidates possessing higher qualification in the relevant fields may also be considered for these positions subject to their suitability of the position.
6. Only passed out candidates are eligible to apply. Candidates awaiting final results are not eligible and need not to apply.

10. No TA/DA will be paid either for attending interview or to the selected candidate to join the position.
