**NOTIFICATION FOR SELECTION OF
MANAGING DIRECTOR / CHIEF EXECUTIVE OFFICER OF APCOB**

APCOB invites applications for selection to the post of Managing Director (MD)/Chief Executive Officer (CEO) from candidates who fulfill the following Fit and Proper Criteria prescribed by RBI/NABARD.

I. Age:

The applicant shall not be above **62 years of age as on the date of notification.**

II. Qualifications:

The person to be appointed as MD/CEO shall possess any of the following educational qualifications:

- a) Graduate with CAIIB/DBF/Diploma in Cooperative Business Management or equivalent qualification; or*
- b) Chartered/ cost accountant; or*
- c) Post Graduate in any discipline;*

III. Experience:

*The applicant shall have at least eight (08) years' work experience at the middle/ senior level in the **Banking Sector**. Senior/ Middle level for the purpose shall be taken as the third level (Scale/cadre) onwards [i.e., excluding the first two levels (scales/cadres) in the Officer cadre], or as the highest two levels (scales/cadres) below the level of CEO.*

IV. General conditions:

1. The appointment will be for an initial period of 3 years from the date of his/her appointment or attaining 65 years of age, whichever is earlier on deputation/ contract basis.
2. The appointment shall be subject to approval of RBI as per NABARD Circular ref: NB.IDD/284-669/Coop Policy/2024-25 dt. 03.07.2024.
3. The application should be submitted in the prescribed format only.
4. The last date for receipt of application in hard copy **30.09.2025** (up to 05:00 PM).
5. In-service candidates should apply only through proper channel. In case, the candidate anticipates any delay in forwarding his/her application for want of employer recommendation, he/she may submit a copy of application along with all the requirements (except

employer recommendation) before or as on the last date i.e., 30.09.2025 However, the application, duly recommended by the employer, shall reach the Bank by **07.10.2025**.

6. The applicant shall have to disclose the information relating to the disciplinary actions pending/proposed and punishments awarded, if any.
7. Applications not complying with the conditions of Age, Qualifications, Experience, fees, employer recommendations etc., will be summarily rejected.
8. A recent passport size photo is to be pasted on the application in the space provided.
9. Application should be accompanied by self-attested true copies of certificates pertaining to proof of date of birth, qualifications, experience and other credentials with the prescribed fee of Rs.500/- by way of NEFT to the Bank A/c details mentioned below or Demand Draft favoring” THE ANDHRA PRADESH STATE COOPERATIVE BANK LTD” payable at Vijayawada.
