The engagement is purely temporary. Minimum eligibility (Qualifications) shall be as per UGC Regulations on Minimum Qualifications for appointment of Teachers, 2018.

The eligibility terms and conditions prescribed for the posts are as follows:

### GUEST FACULTY ESSENTIAL QUALIFICATION FOR ODIA:

- A master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign University.
- Besides fulfilling the above qualifications, the candidates must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or Ph.D or a similar test like SLET/SET accredited by the UGC.

### **GUEST FACULTY ESSENTIAL QUALIFICATION FOR FORESTRY:**

- i. Bachelor's degree in forestry with minimum 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) from an Indian University, or an equivalent degree from an accredited foreign University.
- ii. A master's degree with minimum 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in Forestry with specialization in Forest Products and Utilization (FPU) / Forest Biology and Tree Improvement (FBT) from an Indian University, or an equivalent degree from an accredited foreign University.
- iii. Besides fulfilling the above qualifications, the candidates must have cleared the National Eligibility Test (NET) conducted by the ICAR, UGC or the CSIR, or who have been awarded a PhD degree in the relevant subject.

### **GUEST FACULTY ESSENTIAL QUALIFICATION FOR EDUCATION:**

- i. A master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a Physical Education / Art Education subject from an Indian University, or an equivalent degree from an accredited foreign University.
- ii. Besides fulfilling the above qualifications, the candidates must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or Ph.D or a similar test like SLET/SET accredited by the UGC.

### **GUEST FACULTY ESSENTIAL QUALIFICATION FOR HINDI:**

- i. A master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign University.
- ii. Besides fulfilling the above qualifications, the candidates must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or Ph.D or a similar test like SLET/SET accredited by the UGC.

### **GUEST FACULTY ESSENTIAL QUALIFICATION FOR AGRICULTURE:**

#### **Eligibility (A or B):**

#### **A. i. Essential Qualification:**

- i. Master's degree in relevant subject with at least 55% marks or equivalent grade (wherever grading system is followed) from an Indian University or an equivalent degree from a recognized foreign university in any discipline of Agriculture/Horticulture.
- ii. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the CSIR or ICAR [or] similar test accredited by the UGC like the State Level Eligibility Test (SLET/SET), or who have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009 or 2016 or 2022 and their amendments from time to time as the case may be exempted from NET. Provided the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/ Bye laws/ Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:
  - a) The Ph.D. degree of the candidate has been awarded in a regular mode.

- b) The Ph.D. thesis has been evaluated by at least two external examiners.
- c) An open Ph.D. viva voce of the candidate has been conducted.
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed/ peer-reviewed journal.
- e) The candidate has presented at least two papers based on his/her Ph.D. work in National/ International conferences / seminars / symposiums, sponsored /funded / supported by the UGC / ICSSR/ CSIR / ICAR or any similar agency.

The fulfillment of conditions (a, b, c) is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

### **B. Essential Qualification:**

The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following:

- i. Quacquarelli Symonds (QS)
- ii. The Times Higher Education (THE) or
- iii. The Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

### **GUEST FACULTY ESSENTIAL QUALIFICATION FOR DAIRY SCIENCE:**

#### **Essential Qualifications for Dairy Engineering**

1. B. Tech. Dairy Technology/ Agricultural Engineering/ Food Process Engineering from a recognized Institute/ University with at least 55% marks or its equivalent grade in the point scale.
2. Master's Degree (M.Tech.) in Dairy Engineering/ Post Harvest Technology/ Dairy Process Engineering/ Food Process Engineering with at least 55% marks or its equivalent grade in the point scale.
3. National Eligibility Test (NET) qualified\*[conducted by the CSIR or ICAR or UGC [or] similar test accredited by the UGC like the State Level Eligibility Test (SLET/SET) or who have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009 or 2016 or 2022 and their amendments from time to time as the case may be exempted from NET. Provided the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/ Bye-laws/ Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/ Colleges/ Institutions subject to the fulfillment of the following conditions:
  - a) The Ph.D. degree of the candidate has been awarded in a regular mode.
  - b) The Ph.D. thesis has been evaluated by at least two external examiners.
  - c) An open Ph.D. viva voce of the candidate has been conducted.
  - d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed/ peer-reviewed journal.

- e) The candidate has presented at least two papers based on his/her Ph.D. work in National / International conferences / seminars / symposiums, sponsored / funded / supported by the UGC / ICSSR/ CSIR / ICAR or any similar agency.
- f) The fulfillment of conditions (a, b, c) is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

Note: The selection shall be based only on the performance in the interview.

**Other Terms and conditions:**

1. Selected candidates shall be paid an honorarium of ₹ 1500/- per lecture subject to maximum of ₹ 50,000/- per month.
2. The selected candidates shall be engaged on purely temporary basis for a period of one semester, likely to be extended for another semester on satisfactory performance. However, the engagement will be terminated on the joining of a regular faculty in between. The services of Guest Faculty will be terminated without notice if found unsatisfactory. **Under any circumstances, candidate cannot claim any right for permanent position.**
3. No TA/DA will be paid for attending the walk-in interview.
4. Incomplete applications will be rejected.

6. The Guest Faculty shall not be given the benefit of allowances, pension, gratuity and leave etc. as admissible to the regular teachers.
