3. Place of work will be at ICAR-Indian Veterinary Research Institute, Hebbal, Bengaluru.
4. No TA/DA will be paid for appearing in interview.

6. Above positions are purely temporary & time bound and may be terminated by the Competent Authority without assigning any reason.
7. Only Indian citizens are eligible for appearing in the walk-in-interview.
8. The upper age limits are indicated against the post with relaxation to SC/ST/OBC/PH candidates as per GoI guidelines.
9. Period of contract is one year and extendable based on performance and project duration.
