Note:

- a. Relevant date for determining eligibility with regard to all eligibility criteria such as qualification, experience, age, apprenticeship etc. stipulated in the notification will be "01.11.2025".
- b. Only male candidates are eligible to apply
- c. Requirements are for recruitment on Kerala State basis and candidates applying to these posts shall submit domicile certificate for the State of Kerala.
- d. Candidates who have resigned or were relieved other than at the end of term of contract/ completion of work from temporary/adhoc engagement of FACT will not be considered for engagement.

General terms and conditions for appointment

- 1. For post code 1, the engagement will be for a term of two years, renewable for a maximum period of 2 spells of one year each and for post code 2, for a term of one year, renewable for a maximum period of 3 spells of one year each. Both may be renewed at the discretion of the Management, subject to requirement, performance, assessment etc. Engagement is also liable to be terminated by the Management with 15 days' notice or pay in lieu of notice, at its discretion without assigning any reason.
- 2. Candidates offered engagement as above will be paid a consolidated pay per month as follows

An increase of 3% of consolidated pay will be paid on successful completion of each year. Leave, ESI, Provident Fund, Shift allowance, TA & DA for duty travel will be applicable based on eligibility, as per Rules of the Company.

- 3. Reservation for SC, ST, OBC (NCL), EWS, PWBD and Ex-Servicemen category will be applicable as per Government Directives. EWS candidates shall submit EWS certificate of relevant year (income of 2024-25). OBC-NCL candidates shall produce OBC-NCL certificate issued by competent authority within 6 months prior to joining. Criteria for determining the category shall be as per Government of India directives as applicable to Central Government establishments. Candidates belonging to Persons with Benchmark Disability (PwBD) shall submit Disability Certificate issued by an authority as prescribed in the Rights of Persons with Disabilities Rules, 2017.
- 4. Eligible candidates should have been born on or between 01.11.1990 and 31.10.2007.Relaxation in maximum age limit is permissible upto 5 years for SC/ST candidates, 3 years for OBC (NCL) candidates and 10 years for PWBD (Disability 40% and above) candidates. Relaxation to ExService personnel will be applicable as per GOI guidelines. Matriculation / School leaving certificate granted by Board of Secondary Education shall be the only acceptable document in support of proof of age.



- 5. Educational Qualification must be approved / recognized by UGC (University Grants Commission) / AICTE (All India Council for Technical Education) / AIU (Association of Indian Universities). Candidates with qualifications acquired from foreign universities should produce order/letter in this regard under which it has been approved / recognized by AIU.
- 6. Educational qualification shall be acquired by full time regular course. Those who have studied part time or through correspondence /distance/ private study/off campus course are not eligible to apply. (For Ex-servicemen, the essential qualification acquired/awarded as part of their service and certificate issued by Armed Forces will be considered as eligible).
- 7. The engagement will be subject to the candidate being medically fit and continuing to be medically fit during the period of contract as per the standards prescribed by the Company.
- 8. Engagement under this notification is only for fixed term and will not in anyway directly or indirectly confer any right for extension of term of engagement or for permanent appointment or preferential treatment in appointment in the Company.
- 9. Eligibility of candidates will be determined based on information furnished in application and documents submitted by the candidates. In all stages of the selection process, candidature will be provisional.
- 10. Candidates after preliminary scrutiny of documents submitted along with the application will be **ranked on the basis of the following criteria** in the order given below

For Post Code 01- Canteen Supervisor

- i. Educational qualification, with preference in the order of
 - a. Having Degree in Catering Technology/Catering Science/Hotel Management
 - b. Having three year Diploma in Catering Technology/Catering Science/Hotel Management
 - c. Std X pass with Diploma/Certificate in Catering/Food Production/Food & Beverage of minimum one year duration.
- ii. Earlier year of passing the relevant educational qualification as mentioned in the Course Certificate (Year as mentioned in Course certificate). For Ex-Servicemen, if date of acquiring the qualifying Course is not specified, year of issue of equivalency certificate will be taken.
- iii. Earlier date of birth

Note:

For candidates at i.a & i.b, selection will be based on the ranking criteria ii and iii mentioned above. For the candidates at i. c, selection will be based on the number of completed years of experience (i.e. 5 years & above 'as 5 years', and for those having less than 5 years of experience in the descending order of completed year of relevant experience), followed by criteria ii & iii above.



For Post Code 02 - Cook cum Bearer

Successful candidates in the skill test will be ranked in the order of the following criteria:

- i. Completed years of relevant experience in the order of (a) five years, (b) four years, (c) three years, (d) two years, (e) one year and (f) without experience
- ii. Earlier year of passing the Certificate Course in Food Production/Cooking (year as mentioned in Pass certificate)
- iii. Earlier date of birth.
- 11. Management reserves the right to (i) short list candidates by adopting such methods or criteria found suitable at the discretion of the Management, and (ii) modify the mode of selection etc. The decision of the Company about the mode of selection, requirements, eligibility criteria, shortlisting of candidates etc. shall be final and binding. No correspondence will be entertained in this regard.
- 12. Meeting the eligibility criteria / attending or being successful in the test (if any) by itself will not confer any right on the applicant for selection or to be included in the Panel or for engagement.
- 13. Engagement from the panels will be at the sole discretion of the Management, based on requirements, shift working etc, following reservation rules.
- 14. Interested candidates from the panel may be considered for engagement for periods of shorter duration too, based on requirements of the Company at rates/terms fixed by the Company for such engagement.
- 15. Later engagements, if any, from the list drawn up based on the notification will be subject to meeting the age limits as above, as on the date of engagement.
- 16. (2)Certificates to prove educational qualification from Std X onwards (both mark sheet and Pass Certificate), (3) Certificates to prove relevant experience mentioned in the Application Form, (4) Certificate showing proof of Caste / PWBD/Ex-Servicemen etc, if reservation/relaxation is claimed on account of these,(5) Self Declaration for OBC-NCL candidates, (6) State Domicile Certificate of Kerala, (7) Aadhaar, shall be send by Speed Post/Registered Post to DGM (HR), HR Department, FEDO Building, FACT, Udyogamandal, PIN-683501 so as to reach latest within 7 days from the last date of submitting online form.
