<u>Faculty Recruitment Notification (Rolling) for the vacant Posts of Professor</u> and Associate Professor

Preamble:

This advertisement operates on a rolling basis and has been released with intent to hire faculty to meet the continuous academic and research requirements of the Institute. Interested candidates are invited to submit online applications for the faculty positions at IIIT, Allahabad, throughout the year with no specific last date for receipt of applications. A "Cut- off Date" will be decided and declared by the Institute for considering the sizeable set of applications received till this declared "Cut-off Date" for a particular round/iteration of the Selection process, based on the vacancies existing and/or arising till this date, including backlog vacancies. The applications received after this "Cut-off Date" will be accumulated towards consideration for the next iteration/round of the Selection process. Candidates are thus allowed to apply in the online application portal throughout the year. Eligibility (Qualifications, Experience, Academic & Research Credentials etc.) will be reckoned as on declared "Cut-off date" for every round/iteration.

Indian Institute of Information Technology, Allahabad (IIITA) at Prayagraj (U.P.) is an Institute of National Importance, established in 1999, by the Ministry of Education, Government of India. The Institute offers B.Tech., M.Tech., M.B.A, PhD, and other programs of contemporary relevance to the aspiring learners, in the broad areas of Applied Sciences, Electronics and Communication Engg., Information Technology, Management Studies and their associated niche domains.

IIITA invites *ONLINE applications on Rolling Basis*, for filling of regular faculty positions of Professor and Associate Professor. Individuals having Doctoral degree from Institutions/Universities in India and from abroad, fulfilling the eligibility criteria as per Four-Tier-Flexi Cadre Faculty Structure, with conforming academic credentials, demonstrable high quality research, and committed leadership in & aptitude for innovative teaching-learning, and propensity towards institutional development are encouraged to apply, addressing the needs of the Departments of Information Technology, Electronics & Communication Engineering, Applied Sciences and Management Studies.

1. <u>Important Information on Reservations:</u>

- 1. For the purpose of reservation of posts, as per the Gazette of India, No. 29, the CEI (Reservation in Teachers' Cadre) Act 2019, dated 9th July 2019, the Gazette of India, No. 2289, dated 12th July 2019, and further direction of Ministry of Education vide Notification F.No. 33-3/2018-TS.III dated 5th Nov 2019, the Institution has been treated as one unit.
- 2. The candidates belonging to categories viz. SC/ST/OBC-NCL/PWD/EWS must attach the Caste/Category/Income certificate issued by the competent authority in the prescribed format of the Government of India.
- 3. The Institute follows the Government of India (Central) list for SC/ST and OBC- NCLs.
- 4. NCL certificate for OBC candidates and Income cum Asset Certificate for EWS candidates should not be older than one-year i.e. the candidate shall obtain and submit the relevant certificate, for the previous financial year (2024-25), which is issued on or after 01/04/2025.
- 5. The candidates belonging to reserved category are required to attach the Category certificate in the prescribed format of the Government of India, issued by the competent authority, not below the rank of a Tahsildar or from a first-class Magistrate of the place of domicile of the candidate clearly authenticating the category to which they belong to.
- 6. The reservations for differently-abled persons (PWD) are as per the Govt. of India norms. However, they shall be required to produce a medical certificate in the prescribed form issued by the competent medical authorities for the purpose of employment. Persons suffering from not less than 40% of the disability in a, b, d, and e category as per the Department of Personnel and Training Office Memorandum No. 36035/02/2017- Estt.(Res) dated 15th January 2018 shall only be eligible for the benefit of reservation and other relaxations, if any, as permissible under the rules.
- 7. An EWS candidate shall be eligible for the benefit of reservation and other relaxations, if any, as permissible under the rules as per the Ministry of Social Justice and Empowerment Office Memorandum F.No. 20013/03/2018-BC-II dated 17th January 2019 for reservation of Economically Weaker Sections.
- 8. The Institute encourages applications from qualified women candidates.

Note on Eligibility based on Qualifications and Experience:

- 1. The candidates may refer to the 'Govt. of India-MHRD's F. No. 27-11/2011 Ts.1 dated 23rd April 2014' on 'Implementation of four-tier flexible faculty structure in the Indian Institutes of Information Technology', and the 'CEI Act-2019', for further information, in this regard.
- 2. In case, the candidate has passed and secured CGPA under any other point scale (other than 10-point scale), then the certificate issued by the authorized signatory (and not the Mentor/Supervisor/Head of the Department) of the Institute/University to the effect, will only be considered. Alternately, the CGPA may be equivalently converted on 10-point scale for determination of eligibility.
- 3. The above mentioned CGPA/Percentage/Degree should be awarded by a recognized University/Institute, having the authority to confer/award such degree.
- 4. Candidates having PhD degree directly after B Tech, may also be considered for the participation in the selection process, if they fulfill other criteria.
- 5. The candidates must have relevant teaching experience in a regular grade (as applicable) from the institutes of higher learning.
- 6. The date of birth mentioned in the Online Recruitment Application shall be treated as final. The candidates must attach the relevant document as proof of age with the application.
- 7. All qualifications, experiences and other criteria will be considered as on or before the decided and declared "Cut-off" date for a particular round/iteration of selection process.

A candidate with expertise in the abovementioned fields/areas of the department may be considered eligible for participation in the selection process if they otherwise qualify as per the conditions in this advertisement. However, only those candidates whose areas of research/academics are required for the Institute at the time of the selection process will be considered for stages further.
- 3. The Institute reserves the right to prioritize the required research/academic expertise based on the Institute's needs, at the time of selection process.

3. <u>Selection Process:</u>

- 1. All online applications received till a cut-off date against Rolling Advertisement will be taken into consideration for selection process starting with the scrutiny of applications and short-listing.
- 2. 'Essential Educational qualifications & experience, other essential requirements and additional desirable requirements' mentioned in the Table-I &II above, are the minimum eligibility criteria for academic & research credentials. Mere eligibility will not entitle any candidate for being considered for any part of the selection process.
- 3. The Institute may decide to conduct a selection process comprising of multiple stages for selection of candidates. After Screening/short-listing of applications and profiles of the candidates, by the duly constituted Screening Committee for the purpose, based on the Institute decided criteria, the shortlisted candidates shall be invited for an 'in-person' presentation followed by interview, before the Statutory Selection Committee. Based on the recommendations of this Statutory Selection Committee and approval of the Board of Governors of the Institute, appointment letters shall be issued.
- 4. The Institute reserves the right to prescribe short-listing criteria higher than the minimum criteria (qualifications, eligibility and experience, other academic & research achievements), notified for different positions to arrive at a reasonable number of candidates to be called for presentation and/or interview, before the Statutory Selection Committee. The Institute may adopt some other criterion and/or procedural step to restrict the number of candidates to be invited for interviews before the Statutory Selection Committee.
- 5. The Institute may shortlist the candidates depending upon the requirement of manpower in the particular specialization of different departments in addition to other criteria. The Institute also reserves the right to decide areas of specialization while short listing, taking into account the specific requirements of the individual departments. The short-listing norms may not be uniform across all the departments of the Institute and shall be binding on the applicants.

As an Institute of National Importance, IIIT, Allahabad strives to have a workforce which reflects an all-India character and hence candidates from all over the country, including the women candidates, are encouraged to apply. Only Indian Nationals, Persons of Indian Origin (PIO) and overseas citizens of India (OCI) are eligible to apply. The persons holding the foreign passport are required to provide the details in the application form. Offer of appointment for the individuals with foreign passports will be issued only after the Political and security clearance from Ministries of External Affairs and Home Affairs is obtained.
- 7. IIIT-Allahabad adheres to the 'No In-breeding' policy. Therefore, a candidate who has obtained or is expected to obtain his/her most recent degree (Ph.D.) from IIIT-Allahabad will normally not be considered for recruitment, except where there is a 3 years gap between leaving the Institute and the last date of application.
- **8.** Any Information/Addendum/ Corrigendum/ Clarification will be published only on the Institute website (<u>www.iiita.ac.in</u>). Institute will not be responsible in any manner, if an applicant fails to get any such information and no claim in this regard will be considered.
