- 1. Age limit: SRF:-Minimum age is 21 years for SRF and maximum age is 35 years as on date of interview (age relaxation of five year for SC/ST & Women, and three years for OBC).
- 2. The posts are purely temporary and and will be filled on contractual basis, which may be extended periodically, subject to performance till the termination of the project.
- 3. The selected candidate shall not claim regular appointment at this Institute, as the post is co-terminus with the project.

- 4. The candidates will have to compulsorily fill the application form (typed/filled) as per the format and a recent photograph affixed onto the application form. Self-attested copies of all certificates from matriculation onwards, date of birth certificate, NET/equivalent certificate, proof of experience, no objection certificate (if employed), and publications should be attached with the application form. Candidate should bring project work report/thesis, testimonials/experience certificates, published research papers, etc. to support their claim on experience. The selected candidate will be required to produce all the original documents and medical certificates at the time of joining.
- 5. No objection Certificate (NOC) from the current employer is required, if working.

- 7. Candidates whose near/distant relative(s) is an employee of the ICAR/IARI has to declare it as per the format (declaration) given below. Candidates having no near/distant relative(s) working at ICAR/IARI will also furnish the declaration. This declaration must be attached along with the application form.
- 8. The candidates are required to submit their application through email to subhashree28191@gmail.com as per the format annexed along with the declaration latest by 15th July, 2025. All documents including application should be merged in a single PDF file.
- 9. No TA/DA will be paid for attending the interview and for joining the assignment or on its completion.
- 10. Only the candidates possessing essential qualifications would be interviewed.
- 11. Concealing of facts or canvassing in any form shall lead to disqualification or termination of such candidates.
- 12. All other candidates are also required to compulsorily submit the declaration duly signed in the format annexed along with other documents.
- 13. The SRF will not be entitled for any regular leave, but are allowed to have CL and RH from time to time, not exceeding 10 days in a year. The SRF are full time workers and are required to adhere to the administrative, financial and disciplinary regulations of ICAR-IARI, hence regular attendance of the SRF will be maintained by keeping an attendance register.
