# ADVERTISEMENT FOR ENGAGEMENT OF YOGA INSTRUCTOR ON CONTRACT BASIS AT TRAI HQ, NEW DELHI

Telecom Regulatory Authority of India (TRAI), New Delhi is a statutory body set up under an Act of Parliament viz., TRAI Act, 1997. TRAI has been established to regulate the Telecommunications Services and to protect the interest of service providers and consumers of the telecom sector, to promote and ensure orderly growth of the telecom sector and for matters connected therewith or incidental thereto. The functions relating to regulation of Broadcasting and Cable Services Sectors have also been entrusted to TRAI from 2004.

2. TRAI intends to engage the services of a qualified and experienced Yoga Instructor on a parttime (half day) contract basis. The qualifications, experience and other terms and conditions for engagement of Yoga Instructor will be as follows:

The Yoga Instructor who are willing to offer their services may send their details in the prescribed application format attached herewith clearly indicating their qualification, work experience etc. to the Senior Research Officer (A&P), Telecom Regulatory Authority of India, 6<sup>th</sup> Floor, Tower-F, NBCC World Trade Center, Nauroji Nagar, New Delhi-110029 by 24<sup>th</sup> July 2025, along with self-attested copies of qualification, work experience certificates, etc.
- 4. The additional terms and conditions for engagement of Yoga Instructor are as follows:
- (a) The Yoga Instructor shall be paid a consolidated fixed monthly remuneration of ₹ 77,000/-(Rupees Seventy-seven thousand only).
- (b) The Yoga Instructor is required to visit the office of TRAI located at Tower-F, NBCC World Trade Centre, Nauroji Nagar, New Delhi daily for half a day for 5 days in a week. The Yoga Instructor is required to conduct yoga and pranayama sessions for TRAI staff.
- (c) In case the Yoga Instructor is unable to visit the office on any scheduled day for any reason whatsoever, the Yoga Instructor shall inform the same to concerned officer of GA Section on phone, well in time.
- (d) TRAI shall be responsible for providing a room for yoga sessions with requisite furniture in its office premises.
- (e) The engagement of Yoga Instructor shall, initially, be for a period of one year from the date of joining. The Authority may, however, consider extension beyond this period on yearly basis based on the requirement of TRAI and performance of the instructor up to maximum of 04 years. The engagement may be terminated two months prior written notice from either side or payment of monthly remuneration for the period short of requisite short period, calculated on pro-rata basis.

- (f) The engagement is contractual on the terms and conditions stipulated herein above and it can not be taken as an employment in TRAI either on part-time or full-time basis.
- 4. Applications received after the last date will not be entertained in any circumstances. TRAI reserves the right to accept or reject any or all applications without assigning any reason.
