The posts are located at the Head Office in New Delhi (one post) and the Branch Office in Kolkata (two posts). The period of deputation will not exceed three years.

## A. Eligibility and Pay Scale

- (i) Pay Scale: ₹ 5200-20200/- with a Grade Pay of ₹ 2800/- (Pre-revised) / Level-05 (as per 7<sup>th</sup> CPC).
- (ii) Eligibility Conditions:
  - (a) Officers of the Central Government holding an analogous post on a regular basis in their parent cadre/department; OR
  - (b) Officers with five years of regular service in the grade after appointment to the Pay Band of ₹ 5200-20200/- with a Grade Pay of ₹ 2400/- (Pre-revised) or equivalent in their parent cadre/department
- (iii) Experience: Candidates must have at least two years of experience in Administration, Establishment, and Accounts matters.
- (iv) Age Limit: The maximum age for appointment on deputation is 56 years on the last date of application.
