- I. Tenure of Contract will be 01 year from the date of actual joining.
- II. In case regular incumbent joins in, the appointment shall be terminated immediately. The discretion will be solely of Medical Superintendent.
- III. Private practice will be not allowed.
- IV. Available on call 24x7.
- V. She/He will be entitled for the leave @ 2.5 days for each months of work. On prorata basis in a calendar year.
- VI. The selected specialist must have a professional indemnity policy which should cover the period as desired by ESIC in the bid. 2. Candidate seeking reservation benefits for SC/ST/OBC/EWS must ensure that they are entitled to such reservations per eligibility prescribed in the Notice. They should also be in possession of the required certificates in the prescribed format in support of their claim as stipulated in this Notice. OBC candidates should ensure that they are in possession of valid OBC Certificate issued within such issued by the authority mentioned in the format.

5. Candidates claiming reservation under EWS category should produce their EWS certificate as prescribed vide DoPT, Govt of India OM No. 36039/1/2019-Estt.(Res) dated 31.01.2019. (format enclosed)
