<u>CORRIGENDUM OF EMPLOYMENT NOTICE NO. 02/2022</u> (For the post of Stenographer)

In view of Hon'ble Court's letter no. 59632/A.D.(Misc.)Section dated 27.09.2022, the advertisement for appointment to the post of Stenographer in the Civil Courts of Bihar published vide Employment Notice no. 02/2022 dated 13.09.2022 is modified to this extent as mentioned below: -

A. The **first para** of page **'1 of 6'** of the Employment Notice no. 02/2022 dated 13.09.2022 i.e.

"Online applications are invited from the eligible candidates for appointment to existing 1562 vacant posts of Stenographer on probation initially for a period of two years in the Civil Courts of Bihar in the pay scale of Level 4 (25500-81100) plus usual allowances as admissible under the Rules in the prescribed proforma. The Number of vacancies is subject to increase or decrease."

is substituted as under: -

"Online applications are invited from the eligible candidates for appointment to existing 1562 vacant posts of Stenographer Hindi or English or Bilingual on probation initially for a period of two years in the Civil Courts of Bihar in the pay scale of Level 4 (25500-81100) plus usual allowances as admissible under the Rules in the prescribed proforma. Stenographers in Bilingual shall be given preference. Out of total vacant posts for the Stenographers, number of qualifying candidates in English and Hindi shall be filled in proportion of 75 % and 25 % respectively after deducting number of candidates qualifying in Bilingual. The Number of vacancies is subject to increase or decrease."

B. The **fourth para** of '**Page 5 of 6**' of the Employment Notice no. 02/2022 dated 13.09.2022 regarding marks distribution for skill test for Stenographers i.e.

"There shall be a skill test along with the written examination in the following manner:

- D. The last date for filing online application for the post of Stenographer Hindi / English / Bilingual is extended till 20.11.2022 at 23.59 Hours.
- E. The candidates, who have already applied for the post of Stenographer, will have option to select their Stenography language by editing their online application till extended date of filing application online and failing which their candidature will be considered for the post of Stenographer Bilingual language.
