

SELECTION PROCESS:

The Selection process is proposed to be as under:

- A. The Selection process will be based on NHPC Rules & Procedures for Contract Employment on Fixed Tenure Basis.
- B. The mode of selection will be Personal Interview only, of the eligible and shortlisted candidates. However, the management reserves the right to raise the minimum eligibility standards/ criteria and / or to conduct a screening test, to restrict the number of candidates to be called for Personal Interview, if so required.
- C. In case screening test is conducted, the same shall be qualifying in nature (40% for UR/EWS/OBC(NCL) and 30% for SC/ST/PwBD candidates) and candidates qualifying in the screening test shall be shortlisted for interview based on their marks in screening test. Selection shall be done based on marks secured in Personal Interview only.
- D. The decision of NHPC regarding scrutiny of application and short listing shall be final and binding. Shortlisted candidates will have to qualify in the Personal Interview to be adjudged suitable for empanelment for Engagement. The qualifying marks in Personal Interview shall be as given below:

RESERVATIONS AND RELAXATIONS:

- 01 Reservation for SC / ST / OBC (Non-Creamy Layer) / PwBD (degree of disability 40% or above) will be as per the Govt. Norms & Directives.
- 02 No registration fee will be charged from SC/ST/PwBD/Ex.SM/Women category candidates.
- SC/ ST and PwBD (Persons with Benchmark Disabilities) candidates with 50% marks 03 in qualifying examination are eligible to apply.
- The upper age limit is relaxable by 5 years for SC/ST, 3 years for OBC (Non-creamy 04 layer). It is relaxable by 10 years for PwBD - General, 13 years for PwBD - OBC and 15 years for PwBD - SC/ST candidates.
