- 3. The provisionally shortlisted candidates will have to mandatorily i) upload their documents by logging into the website <a href="www.apssb.nic.in">www.apssb.nic.in</a> using their credentials from 24.01.2025 (11.00 AM) to 29.01.2025 (03.00 PM). The following documents are to be uploaded:
- a. 02 (two) copies of recent passport size photograph.
- b. Matriculation certificate issued by the Board / University for proof of date of birth.
- c. Class X or equivalent marksheet and pass certificate.
- d. APST Certificate (if applicable).
- e. Permanent Resident Certificate (if applicable).
- f. Temporary Residential Certificate (if applicable).
- g. Intimation letter to HoD for those who are in regular Govt. Service.
- h. Discharge book and Pay and Pension Order (PPO) for Ex-Servicemen.
- i. Admit Card.
- 4. Failure to upload documents shall result in rejection of candidature and non-allotment of post.
