- (ii) As per G.O.Ms.No.310, GAD., dated 19.07.2005, 'if a qualified and suitable candidate is not available from Ex-servicemen, the turn allotted to Ex-servicemen shall be deemed to be allotted to Open Competition'. Hence, as the Ex-servicemen are not available, the Roster Points 13 & 37, deemed to be allotted to Open Competition.
- (iii) The selection of the candidate at Sl.No.48 is subject to verification of Sports Certificates by the Sports Authority.
- (iv) The selection of the candidates in respect of BC-E category is subject to the adjudication of the litigation before the Hon'ble Courts and orders from the Government.
