
In view of the above, Additional secretary to APPSC, Vijayawada is requested to conduct grievances for one week for revised priority list and obtain written grievances if any, from the individuals and forward the same to SAAP office for redressal their grievances and to prepare the final priority list for approval of the Government level committee.

Further, it is to inform that, meritorious sports persons for employment in the State Government/similar posts in Govt. Institutions under sports quota, the following documents category wise shall be submitted by the candidates as per G.O.MS.No.74, dt: 09-08-2012.

- Candidate submit the sports certificate along with the backup certificate i.e Participation at higher level shall be considered only When it is supported by winning medals at the lower level.
- Group-I Category post – candidate must be submitted International Championships sports certificate along with Form-I.
- Group-II & III Category post – candidate must be submitted National Championships sports certificate along with Form-II.
- Group-IV Category Post – candidate must be submitted Inter University competitions at National/Zonal/Regional level certificate along with Form-III.
- Last grade post – candidate must be submitted the sports certificate of representing a State School team in the National game for School children (school games) along with Form-IV.

Hence the APPSC should take necessary action accordingly.


