3. The candidature of all the shortlisted candidates is **PROVISIONAL** and subject to them qualifying in the Written Test and their eligibility in all respects as prescribed in the Advertisement and Recruitment Rules. The candidate would be required to produce their latest original certificates / documents in support of their claim relating to age, educational qualifications, category etc., during verification of their documents.

6 . **The Written Test shall be conducted on 25/02/2024 at Itanagar.** Other details pertaining to the venue, timing etc. of the written test shall be intimated separately.

7. *Candidate must note that their candidature is purely provisional at this stage and their appointment will be subject to their name figuring in the provisional select list which shall be prepared after the Written Test, Document Verification and preferences indicated. Apart from that they should fulfill the eligibility criteria as per Advertisement No. APSSB-13/2/2023/917 dated 31st October 2023, including possession of the requisite documents, failing which their candidature may be summarily rejected at any stage.*

8. *Further, the Appointing Authority i.e., the indenting / user department verifies the character & antecedents of the candidates, authenticity of documents / certificates and eligibility as per the Recruitment Rules before finally appointing the candidate(s). Therefore, the provisional shortlisting of a candidate does not confer upon him/her any right of appointment unless the Appointing Authority is satisfied, after such inquiry as may be considered necessary, that the candidate is suitable in all respects for appointment to the post.*
