Subject: Waiting List for the posts of Panchayat Secretary, under Item No. 076 (District Cadre, Rajouri), Department of Rural Development & Panchayati Raj, advertised vide Notification No. 03 of 2022 dated 26.05.2022.



Sir,

Kindly refer to this office letter No. JKSSB-Scry/3/2024-03 (E-7402474) dated 22.05.2024, where-under the Waiting List of candidates for the posts of Panchayat Secretary, Department of Rural Development & Panchayati Raj, advertised vide Notification No. 03 of 2022 dated 26.05.2022 was forwarded to your department for further course of action.

Moreover, in the above mentioned letter this office has requested that the waiting list in case of the selected candidate namely Bhanu Partap Singh (DV S.No: 536-JMU) under OM Category who figures at S.No. 6, Item no. 76, district Cadre Rajouri advertised vide Advertisement Notification 03 of 2022 dated 26-05-2022 may not be operated upon till further intimation.

Further, the case of candidates, Bhanu Partap Singh (DV S.No: 536-JMU) under OM Category who figures at S.No. 6, Item no. 76, and the case of provisionally selected candidate, Aadil Rashid D. V S.No. 550 KMR under Category OM/EWS were placed before the Board in its 309th Board Meeting, which decided as under:-

"After due deliberations and discussions, Board decided to consider the candidate namely Aadil Rashid S/o Ab Rashid Ganie (D.V.S.No. 550-KMR) in place of Bhanu Partap Singh (D.V. S.No. 536-JMU) for the post of Panchayat Secretary, advertised vide Advertisement Notification No. 03 of 2022 dated 26.05.2022, under OM category at Sr. No. 06, item No. 76, District Cadre Rajouri. Board unanimously decided that although the candidate (Aadil Rashid) has marked preferences only in Kashmir Division, but has applied for all districts including districts of Jammu Division, therefore can be allotted the last district (Rajouri) as per his merit position. It was also decided to inform the indenting department accordingly."

Accordingly, the undersigned is directed to convey the above decision of the Board regarding the selection of the candidate as figuring in "Annexure-A" to this communication for the posts of Panchayat Secretary, Item No. 076 (District Cadre, Rajouri), pursuant to advertisement Notification No. 03 of 2022 dated 26.05.2022. with the request to kindly proceed ahead in the matter accordingly. The other terms and conditions, as conveyed vide letter No. JKSSB-Scry/3/2024-03 (E-7402474) dated 22.05.2024, shall remain the same.


The above recommendations shall be subject to the outcome of writ petition(s)/OA(s), if any, pending disposal before any competent Court of jurisdiction. The Selection List shall also be subject to the outcome of any inquiry, involving candidate(s) figuring in this Selection List.

The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of the Category/Degree certificates and ascertaining genuineness/validity or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/Appointing authority.

The Selection of the candidates has been made on the basis of Self-declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage and appropriate criminal proceedings against such candidates/s may kindly be initiated.

Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27.09.2021, the candidates, whose recommendations are released by the Selection Agency, shall submit their Personal Verification Roll (PVR) before the appointing authority within a period of 21 days from its release, failing which the candidate(s) shall forego their right to appointment forthwith.
