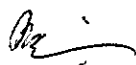

Consequent upon the indent/requisition received from the Department of Disaster Management, Relief, Rehabilitation & Reconstruction vide No. 280/PS/Secy/DMRRR dated 01.10.2020 for 350 posts of "**Sub-Inspector Commercial Taxes**" State Taxes Department (Finance Department) Division Cadre, Kashmir for Kashmiri Migrants and Non Migrants Kashmiri Pandits, the advertisement notification in respect of said posts was issued by the Board vide Notification No. 03 of 2020 dated 01.12.2020 under Item No. 021, with below mentioned category wise break up: -

Pursuant to aforementioned advertisement notification, the Jammu and Kashmir Services Selection Board (JKSSB) vide Notice No. SSB/Secy//Mig/2770-78 dated 10-03-2021 conducted Computer Based Test (CBT) for the posts of Sub-Inspector Commercial taxes (State Taxes Department) from 31st March 2021 & 1st April 2021. On the basis of performance of the candidates in the Computer Based Test, the result/score sheet was notified vide Notification No. SSB/Secy/Sel/2021/3556-64 dated 22.04.2021.

Subsequently, the candidates figuring in the consideration zone were called for Document Verification in a phased manner. In the meanwhile, the Board after due consideration deemed it expedient to seek preferences for different advertised posts under the Prime Minister's Package for Kashmiri Migrants and Non-Migrants Kashmiri



Pandits, from the candidates falling in the consideration zone, so that sufficient candidates are available to fill the available posts without repetition of candidates.

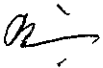
The Government Order No. 10-DMRRR of 2019 dated: 06.03.2019 issued by the Department of Disaster Management, Relief, Rehabilitation & Reconstruction provides for treating of all unfilled reserved category posts except RBA, referred to recruitment agencies, as Open Merit posts in respect of Hon'ble Prime Minister's Package for Relief and Rehabilitation of Kashmir Migrants.

Having regard to the aforesaid position, the Provisional Selection list of the candidates was notified vide this office No. SSB / Secy/Sel/2021/ 5643-52 Dated: 14 .08.2021 calling upon the candidates figuring therein to appear before the Board within seven days alongwith representation for redressal of grievances, if any. The Jammu and Kashmir Services Selection Board received 232 representations which were placed before the in its 187th Board Meeting held on 07-09-2021 and all the aforesaid representations were disposed of in accordance with the laid down norms and procedures.

In addition to above, some representations were received by the Board with regard to candidates who did not upload their documents in phase 1st or appear for document verification in phase 2nd, or were found Not Eligible as per the SRO notifications governing the selection, though figuring in the selection zone. All the aforesaid representations were considered by the Board and disposed off on merits separately vide communication No SSB / Secy/Sel/2021/ /6022-31, No. SSB/SEL//Secy/2021/6032-41 & No. SSB/SEL//Secy/2021/6042-51 dated 08-09-2021.

In light of the aforementioned facts, the Final Selection List prepared by the Selection Committee was considered by the Board in its 187th meeting held on 07.09.2021 and it was decided to notify/publish the same. The Board vide Notification No. SSB/Secy/Sel/2021/6069-79 dated 10.09.2021 (copy enclosed) notify/published the Final Selection List for the post of Sub-Inspector Commercial Taxes" State Taxes Department (Finance Department) Division Cadre, Kashmir and advertisement vide Notification No. 03 of 2020 dated 01.12.2020, Item No. 021, under Hon'ble Prime Minister Special Package for Kashmiri Migrants and Non Migrants Kashmiri Pandits. The Said Final Selection List is enclosed herewith as **Annexure- "A"** for further necessary action in accordance with the rules.

Further, the list notified shall be subject to the outcome of writ petition (s) (if any) pending disposal before any Competent Court of jurisdiction related to the selection.

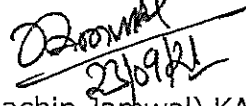
