**Subject: Seeking of preference for the posts of Field Assistant III, Field Supervisor Mushroom, Assistant Store Keeper, Item No 023, 024, 025, Divisional Cadre Kashmir, Depot Assistant and Class IV, Various District Cadres, Item No 026 to 045 Advertised vide Notification No. 03 of 2020 dated 01.12.2020, under PM Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits:-regarding.**

Whereas, the J&K Services Selection Board (JKSSB) advertised various posts **under PM Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits vide Notification No 03 of 2020 dated 01.12.2020, including following posts:**

1. (i) **Field Assistant III, Item No 023.**  
(ii) **Field Supervisor Mushroom, Item No 024.**  
(iii) **Assistant Store Keeper, Item No 025,**

2. (i) **Depot Assistant, Item No 026 to 035.**  
(ii) **Class IV, Item No 036 to 048.**

Whereas, the J&K Services Selection Board (JK SSB), conducted Computer Based Written Test (CBT) examination for the **posts of Depot Assistant and Class IV, Various District Cadres, Item No 026 to 045 on 29<sup>th</sup>, 30<sup>th</sup> of March, 2021 and Field Assistant III, Field Supervisor Mushroom, Assistant Store Keeper, Item No 023, 024, 025, Divisional Cadre Kashmir, on 05<sup>th</sup> of April 2021** in multi sessions/slots respectively; and

Whereas, the result/score sheets of the aforementioned posts have been notified vide this office notice no **SSB/Secy/Sel/2021/3556-64 dated 22-04-2021** on the basis of Percentile Score by using Normalization Procedure; and

Whereas, the provisional shortlist of candidates for the said posts have been notified vide this office notice no **SSB/Secy/Sel/2021/3708-13 dated 30 .04.2021;** and

Whereas, in the shortlists issued for the post of **(i) Field Assistant III (ii) Field Supervisor Mushroom (iii) Assistant Store Keeper**, it has been noticed that some candidates are figuring either in two of these posts or all of three posts. Similarly, in the shortlist issued for the post of **(i) Depot Assistant and (ii) Class IV**, it has been noticed that some candidates are figuring for both the posts of **Class IV and Depot Assistant**.

Now, therefore, in view of the above, all such shortlisted candidates for the post of **(i) Field Assistant III (ii) Field Supervisor Mushroom (iii) Assistant Store Keeper** whose name are figuring for more than one of these posts are hereby called upon to indicate their order of preference for allotment against posts of **(i) Field Assistant III (ii) Field Supervisor Mushroom (iii) Assistant Store Keeper**. Similarly, all such shortlisted candidates for the post of **(i) Depot Assistant and (ii) Class IV**, whose name are figuring for both the posts of **Class IV and Depot Assistant** are hereby called upon to indicate their order of preference for allotment against posts of **(i) Depot Assistant and (ii) Class IV**.
