After obtaining the certificate regarding Physical limitation, from the CMO or any other competent authority as stated above, these candidates shall submit detailed information of their scribe as per proforma at **APPENDIX-II** by email to OPSC (Email ID-opsc@nic.in) which should reach the Office on or before 20.09.2023 positively for consideration of the Commission.

N B:-

(i) The qualification of the scribe should be one step below the qualification of the

candidate taking examination.

(ii) While sending the information about the Scribe, the candidates shall have to clearly mention the PPSAN/Roll No., Name & Date of Birth of the candidate . The candidates shall also furnish the scan **photograph** along with **photocopy of educational qualification** & **specimen signature of the Scribe** .

(iii) The candidate who will fail to furnish the detailed information by the stipulated date

shall **not be allowed** to take assistance of scribe under any circumstances.
